## CHAPTER 69.

Jackson county court terms. An act prescribing the times for holding general terms of the district court in the County of Jackson, in the Seventeenth Judicial district.

Be it enacted by the Legislature of the State of Minnesota:

SECTION I. The general terms of the district court in the County of Jackson, in the Seventeenth Judicial district, shall be held on the third Tuesday in May and the third Tuesday in November of each year.

SEC. 2. All writs, recognizances, bonds, continuances and proceedings issued made or returnable to the district court of said county, as fixed by law prior to the passage of this act, shall be and the same hereby are made returnable to the terms of said court as the same are prescribed by the provisions of section one (1) of this act.

SEC. 3. Chapter ninety-two (92) of the General. Laws of the year eighteen hundred ninety-seven (1897). Chapter sixty-nine (69) of the General Laws of the year

nineteen hundred one (1901), and all other acts and parts of acts inconsistent with this act are hereby repealed.

Sec. 4. This act shall take effect and be in force from and after its passage.
