CHAPTER 78.

Washington
county
bridge ap-
propriation.

An act to amend Section seventy-six (76) of Chapter three hundred nine (309) of the General Laws of nineteen hundred one (1901), entitled "An act to appropriate money out of the internal improvement fund to aid in building bridges and constructing roads in certain counties of this state, and repealing certain appropriations heretofore made for the purpose of building bridges, constructing roads and draining lands in certain counties of this state."

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That section seventy-six (76) of chapter three hundred nine (309) of the General Laws of nineteen hundred one (1901), be and the same is hereby amended so as to read as follows:

"Section 76. That the sum of two hundred (200) dollars be appropriated out of the said fund to aid in the construction of bridges in section seventeen (17) and in section thirty-four (34), in township of May, in the County of Washington, in this state. Said money to be expended under the direction of the board of supervisors of said township of May."

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 79.

Pine and
Kanabec
counties
bridge ap-
propriation.

An act to appropriate money out of the internal improvement fund, to aid in building a bridge across Snake river on the range line dividing Pine and Kanabec counties.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the sum of six hundred (600) dollars is hereby appropriated out of any moneys in the state treasury belonging to the internal improvement fund, or out of the first moneys that shall come into the state treasury belonging to said fund not otherwise appropriated, to aid in the construction of the building of a bridge across Snake river, where said Snake river crosses the range line between ranges twenty-two (22) and twenty-

three (23) west, it being the boundary line between the counties of Kanabec and Pine.

Said bridge shall be built under the direction of the board of county commissioners of Kanabec and Pine counties, and when said work is completed, the said boards of commissioners of both of said counties shall certify the fact to the state auditor, who shall draw his warrant on the state treasurer for said amount in favor of said county.

SEC. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 80.

An act to appropriate money out of the internal improvement fund of this state to aid in constructing a bridge in Pine county, Minnesota.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the sum of four hundred (\$400) dollars is appropriated out of the internal improvement fund for the purpose of aiding in the construction of a substantial wagon bridge across Pokegama creek at or near sec. 14, in twp. 39, range 22, in Pine county, Minnesota.

SEC. 2. That the board of county commissioners of said Pine county shall view said bridge when completed, and examine all contracts, vouchers and accounts respecting the construction of said bridge, and the cost thereof, and make a report of such cost to the state auditor.

And three of said commissioners may act in the premises.

SEC. 3. That upon the receipt of said report by the state auditor, he shall draw his order in favor of said County of Pine on the state treasurer for the cost of said bridge and approaches, not exceeding four hundred (\$400) dollars, and the state treasurer shall pay over such money to the county treasurer of Pine county, upon such order or orders, and such money shall be paid out by the said county treasurer upon the order of the county commissioners of said county in payment of the cost of said bridge and approaches.
