CHAPTER 94.

Reimburse-
ment of
secretary of
state and
insurance
commis-
sioner.

An act to reimburse Elmer H. Dearth and Peter E. Hanson, for moneys paid by them to the state treasurer on account of the Universal Casualty Company of Milwaukee, and to appropriate money therefor.

Whereas, Elmer H. Dearth, as insurance commissioner of the State of Minnesota, received on January 18th, A. D. 1902, from the Universal Casualty Company, a foreign insurance corporation of the State of Wisconsin, a check for fifty-two dollars (\$52) for filing charges, statement and license fee, as required by law, and paid the amount thereof into the state treasury, which check was thereafter protested and has not been paid, and the said Elmer H. Dearth was compelled to pay, and did pay in protest fees, the sum of one dollar and fifty-four cents (\$1.54), which sum he is unable to collect; and

Whereas, Peter E. Hanson, as secretary of state of the State of Minnesota, accepted the check of said Universal Casualty Company for the amount of fifty dollars (\$50). for fees under chapter 69 of the Laws of 1899, and turned the same into the state treasury with his endorsement thereon, which said check was thereafter protested and has not been paid; and

Whereas, The said Peter E. Hanson thereafter was compelled to and did pay into the state treasury the said sum of fifty dollars (\$50), and was compelled to expend and did expend in addition thereto, the sum of one dollar and eighty-three cents (\$1.83) protest fees, which sums he is unable to collect; now, therefore,

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the said Elmer H. Dearth be reimbursed from the state treasury to the extent of fifty-three dollars and fifty-four cents (\$53.54); and that said Peter E. Hanson be reimbursed from the state treasury to the extent of fifty-one dollars and eighty-three cents (\$51.83); and the state auditor is hereby authorized to draw his warrants for the said amounts; and there is hereby appropriated out of any funds in the state treasury not otherwise appropriated, the sum of one hundred five dollars and thirty-seven cents (\$105.37), for the purposes aforesaid.

SEC. 2. This act shall take effect and be in force from and after its passage.

An act to pay J. T. Brooks, Charles E. Weld, Steve Butler, Joseph L. Meyer, P. J. Gruber, D. T. Quealy and O. Halden, for their expenses and services upon a committee acting in conjunction with the public examiner's office in formulating a plan to be reported to the legislature for simplifying the system of accounting of county funds.

Be it enacted by the Legislature of the State of Minnesota:

SECTION 1. That the sum of seven hundred five and 8-100 (705.08) dollars be and is hereby appropriated out of any moneys in the state treasury, not otherwise appropriated, to be paid as follows:

Steve Butler.....	117.50
Joseph L. Meyer.....	101.30
P. J. Gruber.....	59.50
D. T. Quealy.....	118.80
O. Halden.....	90.00

for their services and expenses incurred upon a committee acting in conjunction with the public examiner's office in formulating a plan to be reported to the legislature for simplifying the system of accounting of county funds. That warrants, payable to each of said persons, respectively, or his order, for the respective sums above set forth, be drawn by the proper officer of the State of Minnesota, and delivered to each of said persons, or his order, for said payment.

SEC. 2. This act shall take effect and be in force from and after its passage.
