

## CHAPTER 142—S. F. No. 308.

*An Act to increase the number of stenographic reporters appointed for the municipal court of Minneapolis, Hennepin county, Minnesota.*

Be it enacted by the Legislature of the State of Minnesota :

**Two stenographers for Minneapolis municipal court.**—Section 1. There shall be two stenographic reporters in the municipal court of the city of Minneapolis, Hennepin county, Minnesota, both of whom shall be appointed, compensated and subject to the orders of the court and to removal in like manner as is provided by chapter one hundred and forty-two (142) of the Special Laws of Minnesota for the year one thousand eight hundred and ninety-one (1891) and whose duties shall be such as are specified in said act.

**Appointment of additional stenographers.**—Sec. 2. Upon the passage of this act the judges of said court shall appoint one (1) additional stenographic reporter for said court.

**Compensation.**—Sec. 3. The compensation of such additional stenographic reporter during the year one thousand nine hundred and seven (1907) shall be paid by the city treasurer of the city of Minneapolis out of moneys not otherwise appropriated.

Sec. 4. This act shall take effect and be in force from and after its passage.

CHAPTER 143—S. F. No. 661.

*An Act to provide for the payment of the certificates of indebtedness, issued by the board of state capitol commissioners.*

Be it enacted by the Legislature of the State of Minnesota :

**Two-thirds of a mill tax levied.**—Section 1. To provide for the payment of the certificates of indebtedness issued, according to law, by the board of state capitol commissioners it shall be the duty of the state auditor to set aside from the revenue fund each year a sum equal to a tax levy of two-tenths of a mill upon the assessed valuation of the taxable property in the state. Such transfer by the state auditor shall

be made in 1908, and every year thereafter, until all of said certificates of indebtedness have been fully paid.

Sec. 2. All acts or parts of acts inconsistent with this act are hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its passage.

#### CHAPTER 144—S. F. No. 260.

*An Act to authorize the sale of certain land owned by the State of Minnesota, and with the moneys arising therefrom, together with the money received from the condemnation and taking for railroad purposes of certain other land, to purchase other lands for the use of the St. Peter state hospital for insane.*

Be it enacted by the Legislature of the State of Minnesota:

**Board of control to sell land.**—Section 1. The state board of control is hereby authorized to sell the following described real estate situated in the county of Le Sueur and State of Minnesota, to-wit: So much of government lot five (5) in section No. fifteen (15), in township No. one hundred and ten (110) north, of range No. twenty-six (26) west, as lies west of a straight line extending southwesterly from a point on the north boundary line of said lot, which point is five hundred and four (504) feet west of the northeast corner of said lot to a point on the south boundary line of said lot, which point is thirteen hundred eighty-six and 45-100 (1386.45) feet west from the southeast corner of said lot; and also, so much of government lot six (6) of said section as lies west of a straight line extending southwesterly from a point on the north boundary line of said lot, which point is seventy-three and 45-100 (73.45) feet west of the northeast corner of said lot, to a point on the south boundary line of said lot, which point is nine hundred forty-five and 25-100 (945.25) feet west of the southeast corner of said lot.

**Disposition of proceeds of sale.**—Sec. 2. The moneys received from the sale of said lands, together with the moneys received on account of the condemnation and taking for railroad purpose by the Chicago, St. Paul, Minneapolis & Omaha
