provide for and regulate the setting out and protection of trees, shrubs and flowers in the village, or upon its property.

Sec. 2. This act shall take effect and be in force from and after

its passage.

CHAPTER 479-H. F. No. 627.

An act to regulate the repapering, repainting and recalcimining of rooms in hotels, tenements and dwellings, to prevent the spread of contagious diseases.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Disinfection following contagious diseases.—No wall, partition, or ceiling or any room in which there has been contagious disease in any tenement house, hotel or dwelling shall be repapered, calcimined, or have any other covering placed thereupon unless the old paper or other covering shall have first been disinfected and removed therefrom and the said wall, partition or ceiling cleaned. disinfected and freed from bugs, insects or vermin.

Sec. 2. Violation a misdemeanor.—Any person, firm or corporation violating any of the provisions of this act shall be guilty

of a misdemeanor.

CHAPTER 480-H. F. No. 632.

An act entitled an act to amend Section 981 of the General Statutes of Minnesota for the year 1913, relating to the compensation of county surveyors.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Compensation of county surveyors.—That section 981 of the General Statutes of Minnesota for the year 1913 be and the same is hereby amended so as to read as follows:

Section 981. Except as hereinafter provided, the compensation of county surveyors or their deputies shall be four dollars per day while employed in the performance of their respective duties, including the time necessarily spent in traveling to and from the field of their labor, together with all their necessary expenses, payable by the party or parties who employs the surveyor. The surveyor shall receive one dollar and fifty cents for platting each survey in each section over which his survey extends in the county record book of survey, and fifteen cents per folio for recording and indexing of the surveyor's descriptive fields notes; but in no case shall he receive or charge to exceed two dollars and fifty cents for platting and recording the plats and records of the survey of any one section, and the surveyor's fees for platting and recording the surveys shall be

paid by the county in which the respective lands are situated, and the surveys of the same are kept. Such records shall be public records and open at all reasonable times to inspection by any person. The county board shall, at the expense of the county, provide for the county surveyor all proper and necessary books for keeping such records. Such county record book of survey shall be kept in the office of the register of deeds of the county. Provided, that the board of county commissioners of any county may, in their discretion, fix a higher compensation than four dollars per day, but not to exceed seven dollars and fifty cents per day for any public work.

CHAPTER 481—H. F. No. 657.

An act to amend Section 8, Chapter 296, Laws of 1915, being an act to provide state aid for public schools and for the method of its distribution.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Additional amounts to high schools maintaining training departments for rural teachers.—That section 8, chapter 296, Laws of 1915, be amended so as to read as follows:

Section 8. High schools maintaining a department for training rural teachers shall receive annually sixteen hundred dollars (\$1,600). A school employing more than one teacher in such department may receive not to exceed twenty-four hundred dollars (\$2,400). A school employing more than two teachers in such department and enrolling not less than fifty (50) students, may receive not to exceed three thousand dollars (\$3,000).

CHAPTER 482-H. F. No. 741.

An act to amend Sections 31 and 40 of Chapter 235, Laws 1913, as amended by Sections 19 and 21 of Chapter 119, Laws 1917, which said Chapter 235, Laws 1913, is entitled an act relating to public highways, the powers and duties of counties, towns, villages and cities in relation thereto; the creation of a state highway commission; prescribing its powers and duties, appropriating money therefor and providing for the payment of state aid for the construction and improvement of roads, and authorizing and directing the levy of taxes for highway purposes, and to repeal Section 21 of Chapter 119, Laws 1917.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. 10 mills tax for county road and bridge fund.—That section 31 of chapter 235, Laws 1913, as amended by section 19 of chapter 119, Laws 1917, be amended to read as follows:
