

CHAPTER 28—S. F. No. 140.

An act to appropriate money for the publication of the laws, etc., of the Extra Session in the various newspapers in the state.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **\$10,000 appropriated for publication of Extra Session Laws.**—That ten thousand dollars be and hereby is appropriated out of any funds in the state treasury, not otherwise appropriated, for the publishing of the laws of the extra session in the various legal newspapers of the state, the same to be expended under the direction of the secretary of state.

CHAPTER 29—S. F. No. 142.

An act to appropriate money for expenses of the state government and for other purposes.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Increased salaries for district judges and supreme court janitor.**—The sums hereinafter named, or so much thereof as may be necessary, are hereby appropriated from any moneys in the state treasury not otherwise appropriated, for the purposes specified in the following section of this act, to be available, when not otherwise stated for each of the fiscal years ending July 31, 1920, and July 31, 1921.

Sec. 2. For increases in salaries of the district court judges, active, the sum of \$21,620 available for the year ending July 31, 1920.

Sec. 3. For salaries of district court judges, active, the sum of \$27,600 available for the year ending July 31, 1921.

Sec. 4. For increase in the salary of one janitor of Supreme Court the sum of \$200.

Sec. 5. This act shall take effect and be in force from and after its passage.

CHAPTER 30—H. F. No. 22.

An act to amend subdivision 2 and 8 and adding subdivision 22 of Section 1 of Chapter 400, Laws 1913, relating to the salaries of the judges, officers and employees of the Supreme Court, the employees in the office of the state librarian and judges of the district court.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Salary of members supreme court and attaches.**—That subdivision 2 of section 1 of chapter 400, Laws 1913, be and the same is hereby amended so as to read as follows:

2. Chief justice, seven thousand five hundred dollars; associate justices, seven thousand dollars each; supreme court commissioners, seven thousand dollars each; clerk of supreme court, forty-five hundred dollars; deputy clerk, twenty-five hundred dollars; one assistant clerk and one stenographer, twelve hundred dollars each; supreme court reporter, three thousand dollars; reporter's stenographer, fifteen hundred dollars; marshal, one thousand dollars; janitor, one thousand dollars; each stenographer such sum as shall be fixed by the justice or court commissioner appointing them, not exceeding twelve hundred dollars.

Sec. 2. State librarian and assistants.—That subdivision 8 of section 1 of chapter 400, Laws 1913, be amended so as to read as follows:

8. State librarian, three thousand dollars; assistant librarian, eighteen hundred dollars; second assistant librarian, fifteen hundred dollars; librarian's stenographer, twelve hundred dollars.

Sec. 3. Salaries of district court judges.—That a new subdivision be added to section 1 of chapter 400, Laws 1913, which subdivision shall be numbered 22 and shall read as follows:

22. Judges of the district court, *forty-eight* hundred dollars each from the state and fifteen hundred dollars additional, payable monthly from each county in their respective districts having a population of seventy-five thousand or more.

Sec. 4. All acts and parts of acts inconsistent herewith are hereby repealed.

Sec. 5. *This act shall take effect and be in force from and after its passage.*

CHAPTER 31—S. F. No. 137.

An act fixing the salary of the assistant state librarian.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salary of assistant state librarian.—The salary of the assistant state librarian is hereby fixed at *twenty-one* hundred dollars annually, payable in semi-monthly installments.

Sec. 2. All acts or parts of acts inconsistent herewith are hereby repealed.

Sec. 3. *This act shall take effect and be in force from and after October 1, 1919.*
