million ( $\$ 1,000.000$ ) dollars, par value, for the purpose of enlarging and improving, and providing additional buildings and grounds for such sanatorium.

Sec. 2. Interest not to exceed $53 / 4 \%$-Not sold at less than par.-Such county board may issue and sell the bonds of the county for the purposes hereinbefore specified not exceeding one million ( $\$ 1,000,000.00$ ) dollars par value of such bonds, the principal of which bonds shall mature and be payable in not more than fifteen annual installments as nearly equal as practical, the first annual installment whereof shall mature not more than five years from the issuance of such bonds. Such bonds shall be sold in the manner provided for in section 1856, General Statutes of 1913, but the rate of interest shall in no case exceed five and three-fourths per cent per annum, payable annually or semi-annually, and said bonds shall not be sold at less than par. The board of county commissioners of any such county shall have power to levy under the authority of this act a tax on all the taxable property of the county sufficient to pay said bonds in annual installments corresponding to the amounts of interest and principal thereci as herein provided falling due from year to year.

The county auditor shall extend the tax so levied by the county board in sufficient amounts from year to year to cover principal and interest as they mature.

The credit of the county shall be pledged to the payment of the principal and interest of such bonds. Said bonds shall be signed by the chairman of the board of county commissioners and attested by the auditor of such county and sealed with his official seal and shall have proper interest coupons attached.

The auditor shall keep a record of all bonds issued under the provisions of this act which record shall show the date, number and amount of each bond, rate of interest, time when due and the name of the person to whom issued.

Sec. 3. Proceeds-Purpose.-The proceeds of the sale of such bonds shall be placed with the county treasurer of such county to the credit of the sanatoritum fund and shall be used in accordance with and for the purpose described in this act and for no other purpose whatsoever.

Sec. 4. This act shall take effect and be in force from and after its passage.

## CHAPTER 133-S. F. No. 987.

- An act fixing and rcgulating the salaries, compensations, duties and help of certain county officials in counties having, or which may hereafter have, a population of 380,000 inhabitants or over, and repealing all acts and parts of acts inconsistent herewith.

Be it enacted by the Legislature of the State of Minnesota:
Section 1. Salary of Coroner in certain counties.-The salary of the county coroner of each county of this state having or which may hereafter have a population of 380,000 inhabitants or more, shall be forty-five hundred ( $\$ 4,500.00$ ) dollars per annum.

Sec. 2. Deputies and secretary, Salaries.-The county coroner of any such county shall appoint and employ two deputies who shall each be paid the sum of fifteen hundred ( $\$ 1,500.00$ ) dollars per annum, and one secretary who shall be paid the sum of twelve hundred ( $\$ 1,200.00$ ) dollars per annum, and said coroner, deputies and secretary shall be paid out of any moneys in the county treasury not otherwise appropriated, semi-monthly in the same manner as county officials are now paid, and the same shall be in full compensation for all services rendered by said officers respectively in their general capacities. Said coroner may also appoint such additional deputies as in his judgment may be necessary for carrying on the work in said office but such additional deputies shall be paid by the coroner out of the salary received by him as such coroner.

Sec. 3. Salary of Surveyor.-The County Surveyor in each county having, or which may hereafter have a population of 380,000 inhabitants or over, shall receive from such county a salary of four thousand ( $\$ 4,000.00$ ) dollars per annum for all services performed by him for the county, and in addition thereto the County Surveyor shall be furnished with necessary transportation and reimbursed for such other expenses as may be incurred by him while in the performance of his duties.

Sec. 4. Deputies and clerks. Salaries.-The County Surveyor may appoint and employ two deputies who shall each be paid the sum of twenty-four hundred ( $\$ 2,400.00$ ) dollars per annum. One chief clerk and draftsman who shall be paid the sum of Thirteen Hundred ( $\$ 1,300.00$ ) Dollars per annum; one assistant engineer and rodman who shall be paid the sum of thirteen hundred ( $\$ 1$,300.00 ) dollars per annum; two chain men who shall each be paid not to exceed the sum of twelve hundred ( $\$ 1,200.00$ ) dollars per annum; two chain men for a period of six months each years, who shall each be paid not to exceed one hundred ( $\$ 100.00$ ) dollars per month; one mechanical engineer who shall be paid the sum of eighteen hundred ( $\$ 1,800.00$ ) dollars per annum. In addition such deputies shall be furnished such transportation as may be required in the performance of their official duties.

Sec. 5. Salary of Sheriff.-The salary of the sheriff of each county now having, or which may hereafter have a population of 380,000 inhabitants or over, shall be five thousand ( $\$ 5,000.00$ ) dollars per annum.

Sec. 6. Deputies, jailer, etc.-Salaries.-The Sheriff shall appoint and employ one chief deputy who shall be paid the sum of twenty-eight hundred ( $\$ 2,800.00$ ) dollars per annum; one assist-
ant chief deputy and auditor who shall be paid the sum of two thousand ( $\$ 2,000.00$ ) dollars per annum ; one assistant bookkeeper who shall be paid the sum of fifteen hundred ( $\$ 1,500.00$ ) dollars per annum; one special deputy who shall be paid the sum of fifteen hundred ( $\$ 1,500.00$ ) dollars per annum ; one deputy for tax collections who shall be paid the sum of fifteen hundred ( $\$ 1,500.00$ ) dollars per annum; three outside deputies who shall each be paid the sum of two thousand ( $\$ 2,000.00$ ) dollars per annum; one deputy for the care of the insane, who shall be paid the sum of sisteen hundred ( $\$ 1,600.00$ ) dollars per annum; three outside deputies to attend to the service of criminal and other processes, who shall each be paid the sum of sixteen hundred ( $\$ 1,600.00$ ) dollars per annum; one jailer who shall be paid the sum of fifteen hundred and fifty, ( $\$ 1$,550.00) dollars per annum; one assistant jailer who shall be paid the sum of fifteen hundred ( $\$ 1,500.00$ ) dollars-per annum; one matron who shall be paid the sum of nine hundred ( $\$ 900.00$ ) dollars per annum; four night watchman who shall each be paid the sum of thirteen hundred and twenty ( $\$ 1,320.00$ ) dollars per annum; one cook who shail be paid the sum of twelve hundred ( $\$ 1,200.00$ ) dollars per annum; two deputies in charge of juries who shall each be paid the sum of sixteen hundred ( $\$ 1,600.00$ ) dollars per annum; eight general deputies who shall each be paid the sum of fifteen hundred ( $\$ 1,500.00$ ) dollars per annum; two outside patrol deputies who shall each be paid the sum of fifteen hundred ( $\$ 1,500.00$ ) dollars per annum; three general deputies who shall each be paid the sum of eighteen hundred ( $\$ 1,800.00$ ) dollars per annum; one stenographer who shall be paid the sum of twelve hundred ( $\$ 1,200.00$ ) dollars per annum. The Sheriff shall also appoint and employ as many court room deputies as there are district court judges in and for said county. Said deputies shall attend the court of said judges and perform such duties pertaining to the sheriff's office as the sheriff may require. The compensation of each of said deputies shall be fifteen hundred ( $\$ 1,500.00$ ) dollars per annum.

An expense fund of two thousand ( $\$ 2,000.00$ ) dollars shall be set aside out of the first moneys received as.fees from and after the passage of this act to be used by the sheriff. to meet the current monthly expenses of the office, the money so used to be replaced in said fund at the end of each month when such expense is allowed by the County Board.

Sec. 7. Salary of County Auditor.-The salary of the County Auditor of each county now having or which may hereafter have a population of 380,000 inhabitants or over, shall be five thousand ( $\$ 5,000.00$ ) dollars per annum.

Sec. 8. Deputies, clerks, etc.-Salaries.-The County Auditor shall appoint and empioy one chief deputy who shall be paid the sum of twenty-seven hundred ( $\$ 2700.00$ ) dollars per annum ; one deputy who shall act as clerk of the County Board who shall be. paid
the sum of twenty-six hundred ( $\$ 2,600.00$ ) dollars per annum; one draftsman who shall be paid the sum of two thousand ( $\$ 2,000.00$ ) dollars per annum; one assistant draftsman who shall be paid the sum of seventeen hundred and fifty ( $\$ 1,750.00$ ) dollars per annum; one deputy who shall act as bookkeeper, who shall be paid the sum of eighteen hundred ( $\$ 1,800.00$ ) dollars per annum ; one assistant bookkeeper who shall be paid the sum of seventeen hundred (\$1,700.00) dollars per annum; one settlement clerk who shall be paid the sum of twenty-one hundred ( $\$ 2,100.00$ ) dollars per annum; two assistant settlement clerks who shall each be paid the sum of sixteen hundred ( $\$ 1,600.00$ ) dollars per annum; one warrant deputy who shall be paid the sum of eighteen hundred ( $\$ 1,800.00$ ) dollars per annum; one warrant deputy who shall be paid the sum of seventeen hundred and fifty ( $\$ 1,750.00$ ) dollars per annum; one stenographer who shall be paid the sum of twelve hundred and sixty ( $\$ 1,260.00$ ) dollars per annum ; one head counter deputy who shall be paid the sum of nineteen hundred ( $\$ 1,900.00$ ) dollars per annum; three counter deputies who shall each be paid the sum of eighteen hundred ( $\$ 1,800.00$ ) dollars per annum; four general clerks who shall each be paid the sum of sixteen hundred and fifty ( $\$ 1,650.00$ ) dollars per annum; six general clerks who shall each be paid the sum of sixteen hundred ( $\$ 1,600.00$ ) dollars per annum; two general clerks who shall each be paid the sum of fifteen hundred (\$1,500.00 ) dollars per annum.

Sec. 9. Salary of County Attorney.-The salary of the County Attorney of each county now having, or which may hereafter have a population of 380,000 inhabitants or over, shall be six thousand ( $\$ 6,000.00$ ) dollars per annum.

Sec. 10. Assistants, stenographers, etc.-Salaries.-The County Attorney shall appoint and employ one assistant known as the first assistant county attorney, who shall be paid the sum of forty-five hundred ( $\$ 4,500.00$ ) dollars per annum: one assistant who shall be paid the sum of four thousand ( $\$ 4,000.00$ ) dollars per annum; one assistant who shall be paid the sum of thirty-six hundred ( $\$ 3$,600.00 ) dollars per annum : one assistant who shall be paid the sum of thirty-four hundred ( $\$ 3,400.00$ ) dollars per annum: one assistant who shall be paid the sum of three thousand ( $\$ 3,000.00$ ) dollars per annum; one assistant who shall be paid the sum of twenty-eight hundred ( $\$ 2800.00$ ) dollars per annum; one assistant who shall be paid the sum of twenty-four hundred ( $\$ 2.400 .00$ ) dollars per annum; one assistant who shall be paid the sum of twenty-two hundred ( $\$ 2,200.00$ ) dollars per annum; one assistant who shall be designated as attorney for the County Board of said county whose appointment shall be first approved by said Board, who shall be paid the sum of forty-five hundred ( $\$ 4,500.00$ ) dollars per annum; two stenographers who shall each be paid the sum of sixteen hundred ( $\$ 1,600.00$ ) dollars per annum ; two stenographers who shall each be
paid the sum of twelve hundred ( $\$ 1,200.00$ ) dollars per annum; and two inspectors who shall each be paid the sum of twenty-four hundred ( $\$ 2400.00$ ) per annum.

Sec. 11. Salary of Register of Deeds and Registrar of Titles. The salary of the Register of Deeds of each county now having or which may hereafter have a population of 380,000 inhabitants or over, shall be forty-five hundred ( $\$ 4,500.00$ ) dollars per annum. and during the time he shall also act as Registrar of Titles he shall receive in addition thereto the sum of five hundred ( $\$ 500.00$ ) dollars per annum.

Sec. 12. Deputies clerks etc. Salaries.-The Register of Deeds shall appoint and employ one chief deputy who shall be paid the sum of twenty-seven hundred ( $\$ 2700.00$ ) dollars per annum; one second deputy who shall be paid the sum of two thousand (\$2,000.00 ) dollars per annum; one general deputy who shall be paid the sum of eighteen hundred ( $\$ 1,800.00$ ) dollars per annum; one indexer who shall be paid the sum of seventeen hundred dollars ( $\$ 1700.00$ ) per annum ; one assistant indexer who shall be paid the sum of sixteen hundred ( $\$ 1,600.00$ ) dollars per annum; one general clerk who shall be paid the sum of sisteen hundred ( $\$ 1,600.00$ ) dollars per annum: one vault clerk who shall be paid the sum of nineteen hundred ( $\$ 1,900.00$ ) dollars per annum; one assistant vault clerk who shall be paid the sum of one thousand ( $\$ 1,000.00$ ) dollars per annum; one delivery clerk who shall be paid the sum of eleven hundred ( $\$ 1,100.00$ ) dollars per annum; one pager who shall be paid the sum of twelve hundred ( $\$ 1,200.00$ ) dollars per annum; one chief comparer who shall be paid the sum of seventeen hundred ( $\$ 1,700.00$ ) dollars per annum; one assistant comparer who shall be paid the sum of fifteen hundred ( $\$ 1,500.00$ ) dollars per annum; five comparers who shall each be paid the sum of twelve hundred ( $\$ 1200.00$ ) dollars per annum; seven typists who shall each be paid the sum of eleven hundred ( $\$ 1,100.00$ ) dollars per annum; ten copyists who shall each be paid the sum of one thousand ( $\$ 1000.00$ ) dollars per annum; one stenographer who shall be paid the sum of twelve hundred ( $\$ 1200.00$ ) dollars per annum; during the time the Register of Deeds performs all the duties required by law as Registrar of Titles, he shall appoint and employ one deputy who shall be paid the sum of twenty-four hundred ( $\$ 2400.00$ ) dollars per annum; one second deputy who shall be paid the sum of eighteen hundred ( $\$ 1800.00$ ) dollars per annum; one chief clerk who shall be paid the sum of fifteen hundred ( $\$ 1500.00$ ) dollars per annum.

Sec. 13. Salary of Clerk of District Court.-The salary of the Clerk of the District Court of each county now having or which may hereafter have a population of 380,000 inhabitants or over, shall be four thousand ( $\$ 4,000.00$ ) dollars per annum.

Sec. 14. Deputies, stenographers etc. Salaries.-The Clerk of the District Court shall appoint and employ one chief deputy who
shall be paid the sum of twenty-seven hundred ( $\$ 2,700.00$ ) dollars per annum; one head counter deputy who shall be paid the sum of twenty-one hundred ( $\$ 2,100.00$ ) dollars per annum; one assignment deputy who shall be paid the sum of twenty-one hundred ( $\$ 2100.00$ ) dollars per annum; four deputy clerks who shall each be paid the sum of seventeen hundred ( $\$ 1700.00$ ) dollars per annum; eleven deputy clerks who shall each be paid the sum of sixteen hundred ( $\$ 1600.00$ ) dollars per annum; two deputy clerks who shall each be paid the sum of fourteen hundred ( $\$ 140000$ ) dollars per annum; one bookkeeper and cashier who shall be paid the sum of sixteen hundred ( $\$ 1600.00$ ) dollars per annum; one stenographer who shall be paid the sum of fifteen hundred ( $\$ 1500.00$ ) dollars per annum; one special clerk who shall be paid the sum of two thousand (\$2,000.00 ) dollars per annum.

Sec. 15. Salary of County Treasurer.-The salary of the County Treasurer of each county now having or which may hereafter have a population of 380,000 inhabitants or over, shall be the sum of five thousand ( $\$ 5,000.00$ ) dollars per annum.

Sec. 16. Deputies, clerks, etc.-Salaries.-The County Treasurer shall appoint and employ one chief deputy who shall be paid the sum of twenty-seven hundred ( $\$ 2700.00$ ) dollars per annum; one mortgage registry and inheritance tax deputy who shall be paid the sum of eighteen hundred ( $\$ 1800.00$ ) dollars per annum; one cashier deputy who shall be paid the sum of twenty-one hundred (\$2,100.00) dollars per annum; three cashiers or tellers who shall each be paid the sum of fifteen hundred ( $\$ 1500.00$ ) dollars per annum; one payment listing clerk who shall be paid the sum of fifteen hundred ( $\$ 1500.00$ ) dollars per annum; one chief settlement clerk who shall be paid the sum of eighteen hundred ( $\$ 1800.00$ ) dollars per annum; one assistant settlement clerk who shall be paid the sum of fifteen hundred ( $\$ 1500.00$ ) dollars per annum; two assistant settlement clerks who shall each be paid the sum of fourteen hundred ( $\$ 1400.00$ ) dollars per annum; two assistant settlement clerks who shall each be paid the sum of thirteen hundred ( $\$ 1300.00$ ) dollars per annum; one chief accounting or payment credit clerk who shall be paid the sum of eighteen hundred ( $\$ 1800.00$ ) dollars per annum; one assistant accounting or payment credit clerk who shall be paid the sum of sixteen hundred ( $\$ 1600.00$ ) dollars per annum; two assistant accounting or payment credit clerks who shall each be paid the sum. of thirteen hundred ( $\$ 1300.00$ ) dollars per annum; one bookkeeper who shall be paid the sum of sixteen hundred ( $\$ 1600.00$ ) dollars per annum; one remittance registry clerk who shall be paid the sum of thirteen hundred ( $\$ 1300.00$ ) dollars per annum; one chief receipt deputy who shall be paid the sum of fourteen hundred ( $\$ 1400.00$ ) dollars per annum; one assistant receipt deputy who shall be paid the sum of thirteen hundred ( $\$ 1300.00$ ) dollars per annum; two assistant receipt clerks who shall each be paid the sum
of eleven hundred ( $\$ 1100.00$ ) dollars per annum ; one correspondence clerk who shall be paid the sum of thirteen hundred ( $\$ 1300.00$ ) dollars per annum; one chief counter deputy who shall be paid the sum of eighteen hundred ( $\$ 1800.00$ ) dollars per annum; one assistant counter or transfer deputy who shall be paid the sum of sixteen hundred ( $\$ 1600.00$ ) dollars per annum; one assistant counter or transfer deputy who shall be paid the sum of fourteen hundred ( $\$ 1400.00$ ) dollars per annum; one assistant counter deputy who shall be paid the sum of fourteen hundred ( $\$ 1400.00$ ) dollars per annum; one chief statement deputy who shall be paid the sum of fourteen hundred ( $\$ 1400.00$ ) dollars per annum; three assistant statement clerks who shall each be paid the sum of eleven hundred ( $\$ 1100.00$ ) dollars per annum.

Provided, that any such auditor or county treasurer shall each have authority to command and employ the deputies or other employees of his office without additional compensation to that of such deputy or other employe's usual compensation, and when, as often and to such extent as either said county treasurer or auditor may deem proper, the services of any deputy or other employe in said county treasurer's or auditor's office, for any work of either of said offices, whether or not such work be the usual work of such deputy or other employes or be partly or wholly the usual or proper function of some other deputy or employe.

And, provided further, that either the county treasurer or auditor may, during the year, at his discretion and as often and for as long as he sees fit, reduce the number of clerks in his office and that the salary amounts which may be saved together with whatever has been saved during such year, through necessary vacancies, among any other deputies, clerks and assistants of either county treasurer's or auditor's office, may to any extent needful in any case, be used in the same year by hiring extra help at not to exceed the same rate, for any of the regular work of his office when the same is greater or more hurried than is common throughout the year.

And, provided further, that no such sums or any part thereof as herein provided, shall at any time be used to increase the salaries of any of the employes provided for in this act.

Sec. 17. Salary of Judge of Probate.-The salary of the Judge of Probate of each county now having, or which may hereafter have a population of 380,000 inhabitants or over, shall be six thousand ( $\$ 6,000.00$ ) dollars per annum.

Sec. 18. Clerk of Probate, deputies, etc.-Salaries.-The Judge of Probate shall appoint and employ one Clerk of the Probate Court who shall be paid the sum of twenty-eight hundred ( $\$ 2800.00$ ) dollars per annum; one deputy clerk who shall be paid two thousand one hundred (\$2100.00) dollars per annum; one deputy clerk in charge of guardianships, who shall be paid the sum of two thousand one hundred ( $\$ 2100.00$ ) dollars per annum; one registry clerk who
shall be paid the sum of eighteen hundred ( $\$ 1800.00$ ) dollars per annum; one inheritance tax clerk who shall be paid the sum of eighteen hundred ( $\$ 1800.00$ ) dollars per annum; one machine operator who shall be paid the sum of sixteen hundred ( $\$ 1600.00$ ) dollars per annum; three general clerks who shall each be paid the sum of fifteen hundred $\$ 1500.00$ ) dollars per annum; one general clerk who shall be paid the sum of fourteẹn hundred ( $\$ 1400.00$ ) dollars per annum. One stenographer who shall act as Secretary to the Judge of Probate, who shall be paid the sum of twenty-one hundred ( $\$ 2100.00$ ) dollars per annum.

Sec. 19. Salary of County Superintendent of Schools-As-sistant-Salary--The salaries of the County Superintendent of Schools in each County of this State, having or which may hereafter have a population of 380,000 inhabitants, shall be thirty-six hundred ( $\$ 3600.00$ ) dollars per annum. The County Superintendent of Schools in any such County is authorized to appoint an assistant at a salary not to exceed twenty-five hundred ( $\$ 2500.00$ ) dollars per annum and a clerk at a salary not to exceed fifteen hundred ( $\$ 1500.00$ ) dollars per annum; such salaries to be paid in the same manner as the salaries of other County officials in such County.

Sec. 20. Court commissioners may appoint stenographer-clerk-Salary.-The court commissioner of any county of this State now or hereafter having a population of 380,000 inhabitants or over, shall appoint and employ one stenographer-clerk who shall be paid the sum of thirteen ( $\$ 1300.00$ ) dollars per annum.

Sec. 21. County board may appoint additional help.-The Board of County Commissioners in each county now having or which may hereafter have a population of 380,000 inhabitants or over, shali have the power to appoint and employ such additional help for the various county offices as to them may seem just and proper, and fix the compensation to be paid therefor.

Sec. 22. Salaries to be paid semi-monthly.-The salaries provided for in this act shall be paid semi-monthly.

Sec. 23. Invalidity of one section not to affect other sections. -If any section, clause or part of this act shall be found invalid, the validity of the remainder shall not in any way be affected thereby.

Sec. 24. Inconsistent acts repealed.-All acts and parts of acts inconsistent with the provisions of this statute are hereby repealed.

Sec. 25. Employes not to have other employment.-No person holding any appointive position whose salary is fixed by this act shall, while employed by any such county, perform legal services or carry on any other gainful occupation during office hours except for such county.

Sec. 26. Effective March 31st 1921.-This act shall be in force and effect from and after the 31st day of March, 1921.
