Sec. 7. Applicants registered in other states.—That Section 5009 General Statutes Minnesota 1913 be and the same is hereby amended so as to read as follows:

"5009. The board of examiners may issue license without examination, upon the payment of \$15.00 registration fee, to applicants from another state or foreign country whose qualifications are equivalent to those required by this act, and who shall produce to said board satisfactory evidence verified by the oath of the applicant of the fact that said applicant was duly licensed by said state or foreign country to practice therein as a registered nurse."

Sec. 8. This act shall take effect and be in force from and after its passage.

CHAPTER 149—S. F. No. 895.

An act providing for the erection of a monument at Lake Chetek, in memory of Minnesota citizens massacred in 1862 and consolidating funds heretofore appropriated for that purpose and appointing a commissioner for the administration of such fund.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Certain appropriations consolidated.—That the sum of Four Hundred (\$400.00) Dollars, heretofore appropriated by Chapter 336 of the General Laws of the State of Minnesota for the year 1905, for the removal of the bodies of Minnesota citizens massacred at Lake Chetek on 1862, be and the same hereby is transferred and added to the appropriation of One Thousand (\$1,000.00) Dollars appropriated by sub-section 24 of Section 11 of Chapter 510 of the General Laws of the State of Minnesota for 1921.

Sec. 2. To erect monument.—That the total sum of Fourteen Hundred (\$1400.00) dollars so provided be used for the purpose of erecting a suitable monument with suitable inscription over the graves of said persons so massacred and for acquiring and improving the grounds where said bodies lie buried and for acquiring a right of way thereto from the public highway.

Sec. 3. Commissioners.—That J. E. Baxter, C. A. Portman and Henry Paul, citizens of Murray County be and they hereby are appointed commissioners to carry out the provisions of this act, and administer the money hereby appropriated, without compensation.

Sec. 4. Inconsistent acts repealed.—That all acts inconsist-

ent with the provisions hereof be and the same hereby are repealed.

Sec. 5. This act shall take effect and be in force from and after its passage.

CHAPTER 150—S. F. No. 1151.

An act fixing the salary of county auditors in counties now or hereafter having a population of not less than 28,000 nor more than 28,500 inhabitants.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salary of county auditors in certain counties.—That in every county now, or hereafter having a population of not less than 28,000 nor more than 28,500 inhabitants, the county auditor shall receive an annual salary of three thousand dollars. Such salary shall be paid monthly out of the county treasury upon the warrant of the county auditor.

Sec. 2. Application.—This act shall not apply to counties wherein the salaries of county auditors are fixed by special law, nor to any county wherein the salaries of county officials are fixed by Section 823 General Statutes of Minnesota 1913 as amended by Subdivision 5 of Chapter 494 Session Laws of Minnesota for 1921.

Sec. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 151—H. F. No. 96.

An act to repeal Chapter 236, Laws of Minnesota 1919, relating to annexation of additional territory to school districts.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Law repealed.—That Chapter 236 Laws of Minnesota 1919 be and the same is hereby repealed.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 152—H. F. No. 207.

An act providing co-operation of the State Board of Control and child welfare boards with public authorities charged with the administration of laws for the poor.
