

sentence of Section 3 of Chapter 338 of the Session Laws of Minnesota for 1919 now reading; "Provided that the benefits of this Act shall not extend beyond July 1st, 1924," be and the same hereby is, amended to read as follows:

Section 3. (a) The provisions of this Act shall not apply on tuition which shall have been earned or received after June 30th, 1924. Applications for the benefits of this Act shall be filed with the Adjutant General before 5:00 o'clock P. M. on July 7th, 1924. The Adjutant General shall neither accept, place on file, nor retain in his office any applications which shall not have been delivered to him by the hour and date above specified, but shall disapprove such applications, and shall return them to the applicants. All provisions of this Act shall be null and void after September 30th, 1924; provided, that the cessation of operation of the provisions of this Act shall in no way have the effect of reviving the operation of any Acts or parts of Acts which have been repealed under this Act.

Sec. 2. This Act shall take effect and be in force from and after its passage.

#### CHAPTER 297—H. F. No. 1295.

*An act to accept a donation or donations of not less than fifty thousand dollars from the Minnesota Editorial Association and the Minnesota Bankers Association for the erection of a school building on land belonging to the State of Minnesota near Phalen Park in Ramsey County, Minnesota; establishing and providing for maintaining thereon and thereat a school for the education of indigent, crippled and deformed children to be known as the "Michael J. Dowling Memorial Hall" under the direction of the State Board of Control; and appropriating money for said purposes.*

WHEREAS, the Minnesota Editorial Association and the Minnesota Bankers Association have communicated to the State Board of Control their desire to donate to the State of Minnesota a sum of not less than fifty thousand dollars in memory of the sterling worth and splendid character of the late Michael J. Dowling, formerly of Olivia, Minnesota, to be used in the construction of a school building by the State of Minnesota to cost not less than one hundred thousand dollars on lands now owned by said state and partially occupied by a hospital for indigent, crippled and deformed children near Phalen Park in Ramsey County, Minnesota, and establish and equip there a school for the education and training of indigent, crippled and deformed children to be known as the "Michael J. Dowling Memorial Hall," now therefore;

Be it enacted by the Legislature of the State of Minnesota :

**Section 1. State authorized to accept donation.**—That the state of Minnesota hereby does accept and authorize the State Board of Control to receive, at any time within one year from the date this act becomes effective, a donation or donations amounting in the aggregate to not less than fifty thousand dollars (\$50,000.00) from the Minnesota Editorial Association and the Minnesota Bankers Association for the purposes set forth in the preamble to this Act. And the State Board of Control is hereby further authorized, on behalf of the state, at any time to accept from any person unconditional donations of money made available for the support, maintenance, improvement, extension or other beneficial use of the "Michael J. Dowling Hall" as hereinafter established.

**Sec. 2. "Michael J. Dowling Memorial Hall" established.**—There is hereby established a school for the education and training of indigent, crippled and deformed children of the State of Minnesota, which shall be known as the "Michael J. Dowling Memorial Hall," and such school is hereby located near Phalen Park in Ramsey County, Minnesota, and upon those certain lands donated to and accepted by the State of Minnesota under the provisions of Chapter 81, General Laws of Minnesota for 1907. The building or buildings for such school may be erected upon any part of said lands designated by the State Board of Control. Said school shall be deemed and considered as a unit supplementing the hospital for indigent, crippled and deformed children now located on said lands and shall hereafter be supported and maintained in like manner. All powers of management and control over said hospital now vested by law in the State Board of Control, and not inconsistent with the provisions of this act, are hereby extended and made applicable to said "Michael J. Dowling Memorial Hall."

**Sec. 3. Board of Control to construct building.**—As soon as moneys amounting to not less than fifty thousand dollars (\$50,000.00) shall have been actually received by the said Board of Control from said Minnesota Editorial Association and Minnesota Bankers Association, or either of them, said Board of Control shall proceed as promptly as may be convenient to construct and equip a suitable and appropriate building for said "Michael J. Dowling Memorial Hall," and to open and conduct therein such school. Except as expressly provided otherwise by this act, said Board of Control shall determine the kind of building so to be erected, the equipment thereof, the nature, extent and character of the education and training to be had therein, and the number and selection of indigent, crippled and deformed children to whom said school shall be at any time available. And to that end the said Board of Control may make all necessary or

convenient contracts, employments, rules, regulations and provisions, and do all other acts and things necessary fully to carry into effect the provisions of this Act.

**Sec. 4. Appropriation for building.**—The sum of fifty thousand dollars or so much thereof as may be necessary to complete a total fund of one hundred thousand dollars for the construction of the said building for said "Michael J. Dowling Memorial Hall" is hereby appropriated out of any available moneys in the state treasury not otherwise appropriated. But no part thereof shall be used for any purpose until after the sum of at least fifty thousand dollars shall have been actually received from the donors mentioned in Section 1 of this Act.

**Sec. 5. Appropriation for equipment.**—The further sum of ten thousand dollars or so much thereof as may be necessary for the initial equipment of said "Michael J. Dowling Memorial Hall" is hereby appropriated out of any available moneys in the state treasury not otherwise appropriated. The monies appropriated under Sections 4 and 5 hereof to be available for the fiscal year beginning July 1st, 1924.

**Sec. 6.** This act shall take effect and be in force from and after its passage.

#### CHAPTER 298—S. F. No. 286.

*An act to promote the public health by providing for one day of rest in every seven days, in certain employments.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. One day of rest in certain employments.**—No person shall be employed in, or about, any mechanical or mercantile establishment, factory, foundry, laundry, power plant or stationary boiler or engine room, in this state, more than six days in any one week; provided, however, that this act shall not apply to employees of any common carrier by steam or gasoline or electric railway, nor employees of hospitals, clinics, sanatoriums or dispensaries, who are directly employed in the care of the sick nor to the employees of any telegraph or telephone company or employees engaged in conducting the telegraph or telephone business, nor to employees of any undertaker, undertaking establishment, cemetery association or company, nor to employees of newspaper plants, nor to employees in any canning factory or establishment, nor to employees engaged in the burning of kilns in potteries, sewer pipes or brick and tile factories where continuous fire is necessary, nor to employees in any creamery or cheese factory, in any town, village or city of the third or fourth class, nor employees engaged in the burning
