

connecting with any such bridge, in every such case all that part of any such bridge within the limits of this state shall be considered as a part of such trunk highway system except where any such bridge is owned by a private person or corporation or is operated as toll bridge and said commissioner is authorized and directed to cooperate with the duly authorized authorities of such adjoining state in the maintenance, repair, construction and reconstruction of any such bridge.

CHAPTER 342—S. F. No. 592

*An act to legalize conveyances of real property heretofore made and the records thereof.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Conveyances of real property legalized.**—That all conveyances of real property heretofore made in which a married man or married woman has conveyed real property directly to his or her spouse, or that the husband has conveyed to his spouse and children and the children in turn have re-conveyed an interest to said spouse and mother, or that a husband executed and acknowledged a deed in this state, and his wife executed such deed in a foreign country but did not acknowledge such deed or have the acknowledgement certified, shall be, and the same are hereby declared legal and valid, and the records of such conveyances heretofore actually recorded, and if not recorded, that the register of deeds is hereby authorized to record the same in the proper county on or before September 1, 1925, shall be in all respects valid and legal; such conveyances and records thereof shall have the same force and effect in all respects as conveyances of title and for the purpose of notice, evidence or otherwise, as may be provided by law in regard to conveyances and their records in other cases. Provided, that the provisions of this act shall not apply to any action or proceeding now pending in any of the courts of this state.

CHAPTER 343—S. F. No. 983

*An act providing for agreements for extensions of time for payment of life insurance premiums and lapsing of insurance policies upon failure to pay the same.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Life insurance premiums—Extension of payment.**

That parties to any policy of life insurance now or hereafter issued shall have the right at any time to mutually agree in writing for an extension of time in which to pay a second or subsequent premium on said policy, upon condition that the failure to pay said amount agreed upon at the time agreed, shall lapse the policy as of the date mutually agreed upon in said writing, provided, that no such agreement shall impair any right to extended or paid up insurance which the insured may have under said policy nor any right to have the premiums, any part thereof or the amount payable for such extension charged against the policy under the terms of the policy. No such agreement need be attached to or made a part of the insurance policy so affected.

Sec. 2. This act shall take effect and be in force from and after its passage.

CHAPTER 344—S. F. No. 1095

*An act to amend Section 157, General Statutes 1913, as amended by Chapter 222, General Laws 1923, being a portion of Section 162 General Statutes 1923, relating to counties composing the Fifteenth Judicial District and fixing the times of holding general terms of district court therein.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Terms of district court in fifteenth judicial district.**—That Section 157, General Statutes 1913, as amended by Section 2 of Chapter 222, General Laws of 1923, being a portion of Section 162, General Statutes 1923, be and the same hereby is amended so as to read as follows:

"157. The general terms of the district court shall be held each year in the several counties constituting the fifteenth judicial district of Minnesota, at the times herein prescribed, as follows:

Aitkin county, on the third Tuesday in February and the second Tuesday in September.

Beltrami county, on the second Tuesday in February and the second Tuesday in September.

Cass county, on the third Tuesday in June and the second Tuesday in December.

Clearwater county, on the second Tuesday in April and on the first Tuesday in October.

Crow Wing county, on the first Tuesday in May and the first Tuesday in November.

Hubbard county, on the first Tuesday in June and the first Tuesday in December.
