life refuges or reservations as may have been or may be authorized by Act of Congress; reserving, however, to the State of Minnesota full and complete jurisdiction and authority over all such areas not incompatible with the maintenance and control thereof by the United States for the purposes and under the terms of said Act of Congress.

Sec. 2. Certain lands ceded to United States.—There is hereby ceded to the United States for the purposes of the said Upper Mississippi River Wild Life and Fish Refuge, and so long as it shall use the same therefor, and no longer, all areas of land subject to overflow and not suitable for agricultural purposes, owned by this State, and all jurisdiction of the State of Minnesota to and upon the areas of water of the Mississippi River to and including the main channel thereof, within the boundaries of such refuge as the same may be established from time to time under authority of said act, subject, however, to the same reservation of jurisdiction in and over such areas as provided in Section 1 hereof.

CHAPTER 77-S. F. No. 177.

An act to fix the salary of the county treasurer in counties containing not less than eighty-one nor more than eighty-four full or fractional Congressional Townships and having an assessed valuation of not less than \$6,000,000 nor more than \$12,000,000 and to fix the amount of clerk hire in the office of the treasurer of such counties:

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salary of county treasurer in certain counties.— That in each county of this state containing not less than eighty-one nor more than eighty-four full or fractional congressional townships, and having an assessed valuation of not less than \$6,000,000 nor more than \$12,000,000 the salary of the county treasurer shall be \$2500 per year, to be paid in the manner now provided by law.

Sec. 2. Clerk hire for county treasurer in certain counties.— There shall be allowed and paid for clerk hire in the office of county treasurer in said counties such sum as shall be fixed and determined by the board of county commissioners of such county, not exceeding, however, the sum of \$2800 in any one year.

CHAPTER 78-S. F. No. 910.

An act to fix the minimum salary of the county auditor and county treasurer in counties having an assessed valuation of not less than four million dollars.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salary of auditor and treasurer in certain counties. —In all counties of this state having an assessed valuation of not less than Four Million Dollars the annual salary of the county auditor and county treasurer shall be not less than Two Thousand Dollars. Subject to such minimum the salary of the county auditor and county treasurer in such counties shall be as otherwise fixed by law.

CHAPTER 79-S. F. No. 446.

An act to provide additional salary for the members of the board of county commissioners from March 9, 1923, to January 9, 1925, in counties having not less than 81 nor more than 84 full and fractional townships and having an assessed valuation of not less than \$6,000,000 nor more than \$12,000,000.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salaries of county board in certain counties.— That in all counties of the state having not less than 81 nor more than 84 full and fractional congressional townships, and having an assessed valuation of not less than \$6,000,000 nor more than \$12,-000,000, the several members of the board of County Commissioners shall be paid the further sum of \$20.00 per month as additional salary from the 9th day of March, 1923, to the 9th day of January, 1925, the same to be paid by Auditor's warrant issued in the usual manner for the payment of salaries fixed by law of public officials. Approved March 20, 1925

CHAPTER 80-S. F. No. 83.

(Sec. 923, Note, G. S. 1923.)

An act to amend Section 4 of Chapter 156 of the General Laws of Minnesota for the year 1917, the same being an act relating to sheriffs and their deputies and other assistants, their compensation and expenses, in counties containing not less than eighty congressional townships and having an assessed valuation of more than \$20,000,000 and less than \$50,000,000.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Expense of sheriff and deputies in certain counties.—That Section 4 of Chapter 156 of the General Laws of Minnesota for the year 1917 be and the same hereby is amended so that the same shall read as follows:

"Section 4. The salaries aforesaid shall be paid monthly in
