bargain, sell and convey to the Great Northern Railway Company, of St. Paul, Minnesota, the following parcel of land in the County of Polk, State of Minnesota, to-wit:

"All that part of the SE¼ of the NW¼ and the N¼ of the SW¼ of Section 19, 150 N. 46 W. of the 5th P. M., lying north and west of the existing right of way of the railway of said railway company, and south of a line parallel to and distant 75 feet northerly from the center line of the most northerly leg of the wye track of the railway of said railway company, as now located and established; containing 9.15 acres, more or less."

Sec. 2. Consideration.—In view of the fact that this tract of 9.15 acres of land is a small portion of a large 500 acre tract deeded by the Great Northern Railway Company to the University of Minnesota for Agricultural School purposes; and in view of the further facts that certain improvements are to be undertaken by the Railway Company desirable to the Agricultural School and Station at Crookston, Minnesota, the 9.15 acres of land will be deeded back to the Great Northern Railway Company for the nominal consideration of \$1.00.

Sec. 3. This act shall take effect and be in force from and after its passage.

CHAPTER 376—S. F. No. 1024

An act to amend Chapter 202, General Laws of 1921, the same being "An act fixing the salaries of county commissioners in all counties of this state now or hereafter having a population of 415,000 or more inhabitants."

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salary of county board in certain counties.—That Chapter 202, General Laws of 1921, be, and the same is, hereby amended so as to read as follows:

"Section 1. That in all counties of this state now or hereafter having a population of 415,000 or more inhabitants, each member of the Board of County Commissioners shall receive an annual salary

of three thousand six hundred dollars (\$3,600.00) payable in equal semi-monthly installments as the salaries of other county officials are paid. Said salary shall be in full for all services upon the county or other boards and committees and all other expenses within the county, except such traveling expenses as are now allowed by law.

"Sec. 2. All acts and parts of acts inconsistent with the provisions of this act are hereby repealed.

"Sec. 3. This act shall take effect and be in force from and after its passage."

CHAPTER 377-S. F. No. 1074

An act to amend Section 1, Chapter 105, Session Laws of Minnesota for 1927, which is an act relating to authorizing the University of Minnesota to convey to the City of Minneapolis, Minneapolis, Minnesota, certain parcels of land in County of Hennepin, State of Minnesota, in exchange for other parcels of land, in said county.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. University may exchange lands with the City of Minneapolis.—That Section 1, Chapter 105, Session Laws of Minnesota, 1927, be amended as follows:

"The University of Minnesota is hereby authorized and empowered to grant, bargain, sell and convey to the City of Minneapolis, Minneapolis, Minnesota, the following parcel of land in the County of Hennepin, State of Minnesota, to-wit:

"All that part of the North half of Essex Street as originally laid out, lying between the east line of Church street as originally laid out, and a line formed by the extension of the Southwesterly line of Block 39, St. Anthony City, as originally laid out, to the center line of Essex Street Southeast. Also all that part of the east half of Church street as originally laid out lying between the center line of Essex street and a line 115 feet South of the North line of Block 44, St. Anthony City.
