CHAPTER 120-H. F. No. 523

An act to establish October ninth as Leif Erikson day.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Leif Erikson day.—The ninth day of October is hereby designated as Leif Erikson Day and when it does not fall upon a school day the school day nearest such date is designated as Leif Erikson Day. On such day one half hour may be devoted in the schools to instruction and appropriate exercises relative to and in commemoration of the life and history of Leif Erikson and the principles and ideals he fostered.

CHAPTER 121--H. F. No. 177

An act to permit the regulation by the council of employment of labor on public works in cities of the second class organized and operating under special laws.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Cities of second class may establish residence requirements and wage scale.—That in all cities of the second class in the State of Minnesota the city council shall by ordinances duly enacted with appropriate penalty provisions for the enforcement thereof, have power and authority as follows:
- (a) To establish residence requirements and require that in all construction or repair work on any roads, bridges, sewers, streets, alleys, parks, parkways, buildings, utilities, or any other public work involving the improvement of public property, including schools, all labor, either skilled or unskilled shall meet those requirements.
- (b) To adopt a scale of wages to be paid in all public works and to require that it be a part of the specifications in contracts or be effective in all construction or repair work on any roads, bridges, sewers, streets, alleys, parks, parkways, buildings, utilities, or any other public work involving the improvement of public property, including schools on which work public moneys are to be expended.

Sec. 2. That these powers shall be in addition to all other powers now vested in such cities and in their city councils.

CHAPTER 122—H. F. No. 267

An act fixing the salaries of the chairman, clerk, and treasurer in common school districts, according to a classification based upon both population and assessed valuation.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Salaries of school officers in certain districts.—That in all Common School Districts of this state, having both a population of not less than 1400 inhabitants and an assessed valuation of not less than \$3,000,000, the salary of the chairman is fixed at \$50.00 per month and the salaries of the clerk and treasurer at \$35.00 per month each.
- Sec. 2. Board shall report population.—The population reported to the county auditor by the board of such Common School District and accepted by him shall be the population herein referred to, and the valuation shall be that fixed by the previous year's assessment.
- Sec. 3. Inconsistent acts repealed.—All acts and parts inconsistent with the provisions hereof are hereby repealed.

CHAPTER 123—S. F. No. 251

An act to amend Laws 1929, Chapter 379, Section 2, relating to the acquisition of land for municipal flying field and airport purposes in certain cities.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Cities may establish airport.—That Laws 1929, chapter 379, section 2, be amended to read as follows:
