

CHAPTER 103—S. F. No. 1343

An act relating to the registration of motor vehicles and the payment of motor vehicle taxes for the year 1933.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Motor vehicles must be registered by April 15.—In the year 1933 application for the registration of motor vehicles and payment of the tax thereon may be made on or before April 15. Any motor vehicle for the registration of which application is so made and on which the tax is paid prior to said date shall be deemed to be registered subject to the cancellation, amending or approval of the registration by the registrar, and during the months of January, February, March, April and May 1933, such motor vehicle may be used upon the public streets and highways prior to the issuance for it of the number plates for 1933, provided the number plates duly issued for that vehicle and to the same owner for the year 1932 shall be duly displayed.

Sec. 2. The certification by the registrar to the clerks of the District Court of the several counties of delinquent motor vehicle taxes provided for in Mason's Minnesota Statutes of 1927, Section 2691 shall be made on the 2nd Monday in September 1933.

CHAPTER 104—H. F. No. 1465

An act to legalize and validate the proceedings for the incorporation of certain corporations, and for the amendment thereof.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Certain corporations validated.—That every private corporation heretofore in good faith organized, or attempted to be organized, under the general laws of this State, but where the Articles of Incorporation were not published, and the affidavit of such publication was not filed in the office of the Secretary of State until after the date fixed for the commencement of the corporation, or where the Articles of Incorporation have been recorded with the Register of Deeds, but when published did not contain with the publication the record of the recording with said Register of Deeds, but that such affidavit of proof of such publication of the Articles of Incorporation, without the recording data of the Register of Deeds, has been heretofore filed in the office of the Secretary of State, and where the said Certificate of Incorporation has been amended or attempted to be amended to change the name of

such corporation, but where the amendment of such Certificate of Incorporation has been published only once, and the affidavit of such publication was not filed with the Secretary of State until after the said corporation commenced using the amended name, but such affidavit has been heretofore filed in the office of the Secretary of State, and where the persons organizing such corporation and amending the same have been acting in good faith and corporate meetings have been held and business transacted, and the amended name in good faith used, since the attempted amendment, and such corporation has acted in all things as though there were no errors or omissions in its organization or amendment, the same is hereby declared to be in law a valid corporation de jure, and as amended shall be so deemed, and held in all courts as to all transactions, past and future, the same as though there were no defects in its organization or amendment thereof; provided, this Act shall not affect any action now pending in any court.

CHAPTER 105—S. F. No. 759

An act to amend Mason's Minnesota Statutes of 1927, Section 2815, Subsection 9 relating to compensation and mileage of members of school boards.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Compensation and mileage of members of school board.—Mason's Minnesota Statutes of 1927, Section 2815, Subsection 9 is amended so as to read as follows:

"9. Defray the necessary expenses of the board, including two dollars per day for attending one meeting of the school boards of the county in each year, when called by the county superintendent, and five cents per mile in going to and returning from such meeting, and pay for such record books, stationery and other incidental matters as may be proper."

CHAPTER 106—S. F. No. 1345

An act to amend Chapter 89, General Laws 1931, relating to an act appropriating money to assist in defraying expenses incident to the entertaining of the National Convention of the Grand Army of the Republic to be convened in St. Paul in 1933.
