as required and used for such purposes, the state lands and waters now or heretofore so occupied and used up to an elevation not exceeding 2 feet above the lowest crest of the spillway or overflow dam of such occupant as now constructed; provided that no water control structures shall be used higher than those now or heretofore used. The occupant shall pay to the state annually reasonable compensation for the use of the state lands affected, to be determined by the Commissioner of Conservation after investigation. The occupant shall comply with the following requirements: (1) to pay the State within ninety days after the passage of this Act for all merchantable timber heretofore killed by such development at treble prevailing stumpage prices at the time such timber was killed; (2) to pay the State promptly reasonable compensation for any further damage to state lands or timber heretofore or hereafter caused by such development, other than such as is covered by the compensation paid for the use of the lands as hereinbefore provided; (3) within one year after the passage of this Act to clear all state lands subject to flooding of all timber and brush so far as not already cleared.

Sec. 2. Violations a misdemeanor.—Any person who shall wilfully or knowingly violate any of the provisions of this Act or of any order made thereunder by the Department of Conservation shall be guilty of a gross misdemeanor.

CHAPTÈR 413—S. F. No. 978

An act to appropriate money for expenses of the State Government, and salaries of officials and clerks thereof, and for other purposes, prescribing present and future regulations and limitations relative to, and expenditures of certain portions thereof, including certain appropriations from the Trunk Highway Fund, from the Game and Fish Department Funds, and from certain other funds, and prescribing certain reductions and limitations as to monies hereby appropriated, and as to other funds available for governmental activities of the State; to extend balances of appropriations heretofore made and to authorize the executive council to borrow money in certain cases.

Be it enacted by the Legislature of the State of Minnesota:

'Section 1. Appropriation for expenses of state government.—The sums hereinafter set forth in the columns designated "Appropriations" or so much thereof as may be necessary, are hereby appropriated out of any money in the state treasury not otherwise appropriated for the purposes specified in the following sections of this act, to be available for the fiscal years indicated for each purpose. 'The figures "1933", "1934", and "1935", wherever used in this act shall mean that the appropriation, or appropriations listed thereunder shall be available for the year ending June 30, 1933, 1934, and 1935, respectively.

Where an appropriation is made in this act and there remains a balance in a previous appropriation for the same purposes, such balance shall be added to and become a part of such appropriation, except as herein otherwise specifically provided.
- Sec. 35. Inheritance tax paid to county.—The state auditor and state treasurer are hereby authorized to pay to the county treasuries of the several counties of the state on or before November 1, 1934, and 1935, the amounts due the respective counties as their share of the state inheritance tax under the provisions of Section 21-D, Chapter 209, General Laws 1911, and acts amendatory therof.
- Sec. 36. Executive council may borrow money.—Whenever it becomes necessary in order to meet the current demands upon

the revenue funds for the payment of appropriations, the executive council may, at any time, prior to June 30, 1935, make such agreement with banks or other corporations or persons as they may deem advisable and necessary to pay warrants issued against said revenue fund, pursuant to any such appropriation prior to the time when the money to meet such appropriation comes into the state treasury and whenever any warrants are so issued for the accommodation of the state, and paid, the money necessary to pay interest upon the amount of such warrants from the time when such payment was made until the money to redeem such warrants comes into the state treasury at the rate agreed upon by said executive council is hereby appropriated.

Sec. 37. Salaries reduced.—All of the foregoing appropriations have been made on the basis of salary reductions of twenty per cent (20%) on any and all salaries and wages exceeding the sum of \$1200 per annum, no salary, however, to be reduced below the sum of \$1200 per annum. The reductions herein prescribed are to be construed as an emergency provision, applicable only to the years ending June 30, 1934, and June 30, 1935.

The various State Department heads are hereby given authority to reduce salaries as nearly as may be upon an equitable basis and in any manner that they deem best, having regard to the circumstances and experience of the employee involved, but such adjustment shall not in any event exceed the appropriations made for salaries and wages of the department involved.

Such authority to reduce salaries shall apply to all positions and to all salaries in each and every state department, whether fixed by law or otherwise, and whether such salaries are paid from state appropriations, fees, special funds or otherwise, hereby suspending and repealing all laws in conflict with this section.

The heads of all state departments to which no appropriations are made are hereby directed and required to effect similar reductions in the total amounts of the payrolls of their respective departments, in keeping with the salaries received by department heads and employees of state departments specifically designated in this act.

All such reductions in salary shall be approved by the Commission of Administration and Finance, and are subject to the provisions of Chapter 426, Laws 1925.

This act shall not affect the salary of the Governor nor the salaries of persons now judges of the Supreme Court or of the District Court during the term for which said judges have been

elected, nor to retired supreme court, or district court judges and commissioners, but shall apply to all judges who shall be elected or appointed hereafter and to incumbent judges who shall be reelected hereafter prior to June 30, 1935; provided, however, that such incumbent judges may voluntarily reduce their own salaries by 20% and that such action shall not be construed to be a violation of the corrupt practices act.

Sec. 38. This act shall take effect and be in force from and after its passage.

CHAPTER 414-H. F. No.1241 .

An act relating to taxes and tax sales and the discharge and assignment of and redemption from taxes held by the State in certain cases and amending Mason's Minnesota Statutes of 1927, Section 2139 as amended by Laws 1929, Chapter 415, and Laws 1931, Chapter 129; and relating to and extending the period of redemption of lands sold for the taxes for the year 1926 and of lands sold for the taxes for the year 1927, Chapter 119.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Unredeemed lands—conduct of sale.—That Mason's Minnesota Statutes of 1927, Section 2139 as amended by Laws 1929, Chapter 415, and Laws 1931, Chapter 129, be amended to read as follows:

2139. Subd. (a). Such sale shall be conducted by the county auditor. Each parcel shall be sold to the highest cash bidder therefor but not for a less sum than the aggregate taxes, penalties, interest and costs charges against it, unless the cash value thereof fairly determined by the county board and approved by the Minnesota Tax Commission shall be less than such aggregate, in which case the value so fixed and approved shall be the minimum price for which such property may be so sold. The rights of the purchaser at such sale shall be subject to the rights of any purchaser and of the state or its assignee by virtue of any delinquent tax sale held in 1928 or any subsequent year, and of any subsequent delinquent taxes attaching thereto or required to be paid in case of redemption therefrom.
