for the purpose of paying, funding and retiring such outstanding warrants. Except as otherwise provided herein, said bonds and the procedure for the issuance thereof shall conform to the requirements now provided for by general law for the issuance of bonds by counties. No bonds shall be issued pursuant to the provisions of this Act unless the county board of such county shall within six months after the passage and approval hereof, adopt a resolution determining to issue such bonds and determining the validity of the warrants to be funded thereby, which determination, shall be conclusive upon such county as to such validity.

Sec. 2. This Act shall take effect and be in force from and after its passage.

## CHAPTER 32-H. F. No. 165

An act to appropriate the sum of \$15,000 to the Division of Securities of the Department of Commerce of the State of Minnesota. Be it enacted by the Legislature of the State of Minnesota:

Section 1. Appropriation for investigation by securities commission.—There is hereby appropriated, out of the moneys in the state treasury not otherwise appropriated, the sum of Fifteen Thousand (\$15,000) Dollars, or so much thereof as may be necessary, to the Division of Securities of the Department of Commerce of the State of Minnesota, for the use of said Division in connection with the investigation by it of the sale of securities by the Northwest Bancorporation and First Bank Stock Corporation.

## CHAPTER 33-H. F. No. 178

An act to appropriate money for the payment of mileage of the members of the Legislature and for the payment of the per diem of the officers and the employees of and all other expenses of the Legislature and necessary expenses of the members, including payment for supplies necessary therefor.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Appropriation for legislative expense.—\$50,000.00 appropriated for legislature expenses. That the sum of \$50,000 or so much thereof as may be found necessary be, and the same is hereby appropriated from the revenue fund for the payment of the per diem of the officers and employees of and all the other expenses of the legislature, and necessary expenses of the members, including payment for supplies necessary therefor.

Sec. 2. This Act shall take effect and be in force from and after its passage.

## CHAPTER 34-S. F. No. 57

An act directing the Governor to convey certain state lands to the United States for Minnesota Indian sanatorium purposes.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Governor to convey state lands for sanatorium purposes.—The Governor of the State of Minnesota is hereby directed to convey to the United States of America, for the purpose of establishing and maintaining a sanatorium for the treatment of tubercular Minnesota Indians, a tract of land to be selected by the State Board of Control and not to exceed forty acres in size, said tract of land to be appropriated from state owned land now devoted to the use of the Minnesota State Sanatorium for consumptives in Cass County, Minnesota, subject to the right of the state to cause its civil and criminal process to be executed therein.

## CHAPTER 35—H. F. No. 62

An act to establish a Municipal Court in the Village of Perham, Otter Tail County, Minnesota.
