CHAPTER 174—S. F. No. 860

*An act to authorize any bank organized under the laws of this State to invest not to exceed ten per cent of its capital in the capital stock of certain agricultural credit corporations.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Authorized investments for state banks.**—Any bank organized under the laws of this state is authorized to invest not to exceed ten per cent of its capital in the capital stock of any Agricultural Credit Corporation organized under the laws of this state, and entitled to discount privileges with any Federal Intermediate Bank organized under the laws of the United States of America.

CHAPTER 175—S. F. No. 888

*An act authorizing and directing the Governor to convey to certain occupants certain lands situated in Section 16, Township 57, North of Range 17 West in St. Louis County, Minnesota.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Governor to issue deeds in certain cases.**—The Governor of the State of Minnesota is hereby authorized and directed to execute a deed for a consideration of ten dollars per acre, conveying from the state to the grantees herein named, the following described land involved in a change and relocation of property and lake shore line of lands previously sold by the State of Minnesota, to-wit:

(1) To August Nyfors, grantee—assuming the east line of the southwest one-quarter of the northwest one-quarter, Section 16, Township 57 N., Range 17 W. to be due north and south, beginning at a point 751 feet north of the south 1/16 post of said northwest one-quarter, thence 92 feet N. 85 degrees—30 minutes W.; thence 83 feet N. 52 degrees—10

minutes E., thence 84 feet N. 18 degrees—20 minutes E., thence 138 feet due south to point of beginning containing approximately .174 acres.

(2) To Salem Friedman, grantee—assuming the east line of the southwest one-quarter of the northwest one-quarter, Section 16, Township 57 N., Range 17 West, to be due north and south, beginning at a point 676 feet north of the south 1/16 post of said northwest one-quarter, thence 136 feet N. 85 degrees—30 minutes W., thence 72 feet N. 28 degrees—00 minutes E., thence 12 feet N. 52 degrees—10 minutes E., thence 92 feet S. 85 degrees—30 minutes E., thence 75 feet due south to point of beginning containing approximately .241 acres.

(3) To Fred Erickson, grantee—assuming the east line of the southwest one-quarter of the northwest one-quarter, Section 16, Township 57 N., Range 17 W., to be due north and south, beginning at a point 413 feet north of the S. 1/16 post of said northwest one-quarter, thence 192 feet N. 85 degrees—30 minutes W., thence 36 feet N. 12 degrees—00 minutes E., thence 162 feet N. 5 degrees—20 minutes E., thence 66 feet N. 28 degrees—00 minutes E., thence 136 feet S. 85 degrees—30 minutes E., thence 263 feet due south to point of beginning containing approximately 1.038 acres.

(4) To Vern Lofdahl, grantee—assuming the east line of the southwest one-quarter of the northwest one-quarter, Section 16, Township 57 N., Range 17 W., to be due north and south, beginning at a point 338 feet north of the S. 1/16 post of said northwest one-quarter thence 208 feet N., 85 degrees—30 minutes W., thence 76 feet N. 12 degrees—00 minutes E., thence 192 feet S., 85 degrees—30 minutes E., thence 75 feet due south to point of beginning, containing approximately .344 acres.

(5) To Harry Paglianiri, grantee—assuming the east line of the southwest one-quarter of the northwest one-quarter, Section 16, Township 57 N. Range 17 W., to be due north and south, beginning at a point 169 feet north of the S. 1/16 post of said northwest one-quarter, thence 225 feet N. 85 degrees—30 minutes W., thence 108 feet N. 2 degrees—00 minutes E., thence 60 feet N. 12 degrees—00 minutes E., thence 208 feet S. 85 degrees—30 minutes E., thence 169 feet due south to point of beginning, containing approximately .866 acres.

(6) To Gust Levine, grantee—assuming the east line of the southwest one-quarter of the northwest one-quarter, Section 16, Township 57 N. Range 17 W., to be due north and

south, beginning at the S. 1/16 post for said northwest one-quarter, thence 230 feet N. 85 degrees—30 minutes W., thence 170 feet N. 2 degrees—00 minutes E., thence 225 feet S. 85 degrees—30 minutes E., thence 169 feet due south to point of beginning, containing approximately .980 acres.

#### CHAPTER 176—S. F. No. 1033

*An act to authorize coroners in counties having or which may hereafter have a population of 400,000 inhabitants or over to appoint a clerk-stenographer, and fixing and providing for the payment and compensation of such clerk-stenographer and repealing acts inconsistent therewith.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. Employees in coroner's office in certain counties.**—In addition to such deputies, secretary, morgue keeper and assistance to the morgue keeper as are now authorized by law the county coroner of any county now having or which may hereafter have a population of 400,000 inhabitants, or over shall appoint and employ a clerk who shall also be a stenographer and shall be designated as "clerk-stenographer," who shall be paid the sum of \$1200.00 per annum out of any moneys in the county treasury, not otherwise appropriated in semi-monthly installments in the same manner as county officials are now paid, and the same shall be in full compensation for all services rendered by such clerk-stenographer.

**Sec. 2. Inconsistent acts repealed.**—All acts and parts of acts insofar as the same are inconsistent with the provisions of this act are hereby amended, modified or repealed as the case may be.

**Sec. 3.** This act shall take effect and be in force from and after its passage and approval.
