CHAPTER 25—H. F. No. 214.

An act authorizing the Minnesota State Agricultural Society to convey certain lands to the University of Minnesota.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. May convey certain lands.—The Minnesota State Agricultural Society is hereby authorized and directed to execute a deed conveying from the Minnesota State Agricultural Society to the University of Minnesota the following described tract of land, lying and being in Ramsey County, Minnesota, to-wit:

The West One-half of the Southwest One-quarter of the Southwest One-quarter (W½ of SW¼ of SW¼) of Section Twenty-one (21), Township Twenty-nine (29), North of Range Twenty-three (23) West, containing Nineteen and eighty-two one-hundredths (19.82) acres more or less.

CHAPTER 26-S. F. No. 7.

An act amending Laws 1929, Chapter 388, Section 5, Subdivision (d), relating to elementary school special certificates and validating certain certificates heretofore issued by the State Board of Education.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Elementary school special certificates.—Laws 1929, Chapter 388, Section 5, Subdivision (d) is hereby amended to read as follows:

(d) The Elementary School Special Certificate shall qualify any holder thereof to teach Kindergarten-primary, Music, Fine Arts, Industrial Arts or Physical Education, or such other special subject as the needs of the school may, from time to time, require, in any elementary school, and shall be issued to any person who holds a diploma of a Minnesota State Teachers College, or the College of Education of the University of Minnesota, showing that such holder has completed its standard course in the special subject or subjects as to which he applies for a certificate to teach, and may also be issued to any person who has completed an essentially equivalent course in an institution accredited and approved

by the State Board of Education for training teachers in such special subjects.

An Elementary School Special Certificate, which shall qualify any holder thereof to teach defective children in any elementary school, may be issued by the State Board of Education, in its discretion, to any qualified elementary teacher, upon satisfactory showing to such board that the applicant is possessed of such other qualifications for such teaching as the State Board of Education may, from time to time, prescribe.

Sec. 2. Certificates validated.—Any such Elementary School Special Certificate heretofore issued by the State Board of Education qualifying the holder thereof to teach Kindergarten-primary is hereby validated in the same manner as if issued by said Board subsequent to the passage of this amendment.

CHAPTER 27-H. F. No. 48.

An act to amend Laws 1933, Chapter 96, as amended by Laws 1935, Chapter 23, relating to salaries of county officers and to clerk hire in certain offices in certain counties.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Salaries of county officers in certain counties.— Laws 1933, Chapter 96, as amended by Laws 1935, Chapter 23, is hereby amended so as to read as follows:
- "Section 1. That the county board of any county now or hereafter having a population of not less than 55,000 nor more than 70,000 inhabitants, according to the last federal census, and consisting of not less than 35 nor more than 45 congressional townships, shall, and hereby is authorized to, fix the salaries of the county auditor, county treasurer, judge of probate, register of deeds, clerk of the district court, county attorney, superintendent of schools and sheriff of such county at not more than \$3,500 per year.
- Sec. 2. Fees to be paid into the general fund.—The fees of such offices shall not be made a part of or an addition to such
