Be it enacted by the Legislature of the State of Minnesota:

Salary of employees of register of deeds in certain counties.—The Register of Deeds shall appoint and employ one chief deputy who shall be paid the sum of \$3600.00 per annum; one second dupty who shall be paid the sum of \$2200.00 per annum; one general deputy who shall be paid the sum of \$1980.00 per annum; two chattel mortgage abstract clerks who shall each be paid the sum of \$1980.00 per annum; one indexer who shall be paid the sum of \$1,870.00 per annum; one general clerk who shall be paid the sum of \$1800.00 per annum; one vault clerk who shall be paid the sum of \$2,090.00 per annum; one assistant vault clerk who shall be paid the sum of \$1,500.00 per annum; one pager who shall be paid the sum of \$1,320.00 per annum; one chief comparer who shall be paid the sum of \$1,870.00 per annum; one assistant comparer who shall be paid the sum of \$1,650.00 per annum; eight comparers who shall each be paid the sum of \$1,320.00 per annum; fifteen typists who shall each be paid the sum of \$1,210.00 per annum; two typists who shall each be paid the sum of \$1,320.00 per annum; ten copyists who shall each be paid the sum of \$1,200.00 per annum; one stenographer and Receipt book clerk who shall be paid the sum of \$1,320.00 per annum; one bookkeeper-cashier who shall be paid the sum of \$1800.00 per annum; one abstract clerk who shall be paid the sum of \$3600.00 per annum; three tract clerks who shall each be paid the sum of \$1800.00 per annum; during the time Register of Deeds performs all the duties required by law as Register of Titles, he shall appoint and employ one chief deputy registrar of titles who shall be paid the sum of \$3600.00 per annum; one deputy who shall be paid the sum of \$2,520.00 per annum; two deputies who shall each be paid the sum of \$1,980.00 per annum; one tract clerk who shall be paid the sum of \$1800.00 per annum; two clerks who shall each be paid the sum of \$1,650.00 per annum."

CHAPTER 293-H. F. No. 959

An act to authorize the board of county commissioners to levy taxes in excess of present limitations for revenue purposes in certain counties.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Tax levy for revenue in certain counties.—In all counties of this state containing not less than 10 nor more than 15

full or fractional congressional townships, with a population of not less than 17,000 nor more than 23,000 inhabitants according to the last federal census and having an assessed valuation, exclusive of money and credits, of not less than 7,000,000 nor more than 13,000,000 dollars the board of county commissioners may levy for general revenue purposes, not in excess of 60,000 dollars, that may be necessary to defray the expenses, payable from the county revenue fund.

Sec. 2. This act shall take effect and be in force from and after passage.

CHAPTER 294-H. F. No. 944

An act to fix salaries of aldermen in cities now or hereafter having over 50,000 inhabitants.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salary of alderman in certain cities.—That in cities now or hereafter having over 50,000 inhabitants and not having a commission form of government the salary of each alderman shall be \$2400.00 per annum, payable pro rata monthly, out of the city treasury.

Sec. 2. All acts and parts of acts inconsistent with this act are hereby repealed.

CHAPTER 295-H. F. No. 876

An act legalizing and validating certain deeds executed by the trustees of religious corporations.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Certain deeds legalized and validated.—All deeds of real property heretofore made by the trustees of any religious corporation conveying real property within this state belonging to such corporation which were recorded prior to January 1, 1931, in
