## SESSION LAWS

(1) if benefits have been paid with respect thereto;

(2) unless the individual was eligible for benefits with respect thereto in all respects except for the requirements of subsections (b) and (c) of this section;

(3) unless it occurs within the 13 consecutive weeks preceding the week for which he claims benefits, provided that this condition shall not interrupt the payment of benefits for consecutive weeks of unemployment nor require any individual who, prior to the first day of his benefit year, shall have accumulated such two waiting period weeks, to accumulate more than three additional waiting period weeks during his ensuing benefit year;

(4) unless it occurs after benefits first could become payable to any individual under this act.

(e) He has within the first four out of the last five completed calendar quarters immediately preceding the first day of his benefit year, earned wages for employment by employers of not less than sixteen times his weekly benefit amount, provided, that when the first day of a benefit year shall occur during the first calendar quarter in the year 1938, this requirement shall be deemed to be satisfied if the individual, within the first three out of the last four completed calendar quarters immediately preceding the first day of such benefit year, has earned wages for employment by employers of not less than twelve times his weekly benefit amount; and provided further, that if the aforesaid wages of an individual during such period of three or four calendar guarters have been reduced below the required amount because of some mental or physical disability due to services in the armed forces of the United States in time of war, wages earned by such an individual in employment by an employer during his base period, shall be substituted for those earned in such periods of three or four calendar quarters."

Sec. 3. That this act shall be in force and effect from and after its passage.

## CHAPTER 44—S. F. No. 823

An act to authorize the Secretary of State to refund penalties paid for delayed 1937 motor vehicle registrations made before March 15, 1937.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Secretary of State to refund penalties.—The Secretary of State is hereby authorized to refund penalties paid for delayed registration on 1937 motor vehicle registrations made before March 15, 1937. To make these refunds he shall follow the procedure provided by Mason's Minnesota Statutes 1927, Section 2682, as amended by Laws 1931, Chapter 174, for making other refunds.

Sec. 2. This act shall be in effect from and after its passage.

## CHAPTER 45-H. F. No. 797

An act authorizing the governing body of certain municipalities to convey certain land to cemetery associations.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Land may be conveyed to cemetery associations in certain cases.—Whenever any land situated within any town or village in this state, which land heretofore and prior to 1870 has been devoted to and used by the public without restriction as a cemetery, the governing body of the town or village, wherein such lands are situated, is hereby authorized to convey such lands to any cemetery association, organized for the purpose of acquiring said lands for cemetery purposes, upon such terms as such governing body may deem advisable.

Sec. 2. This act shall take effect and be in force from and after its passage.

## CHAPTER 46—S. F. No. 776

An emergency act for the suspension of the termination or cancellation of certain leases of real property except in the manner provided by this act, conferring jurisdiction upon the district court to order the termination of such leases upon default or to extend the time within which the lessee may perform the conditions in default, prescribing the procedure upon petition to the court for an order terminating such leases and providing for notice thereof.
