

mission within two years from the date of such tax certificate or state assignment certificate.

**Section 3. Canceled tax to be reinstated.**—Whenever a refund is granted under the provisions of this act the county auditor shall reinstate such portion of the tax on the land as the value of the land without any improvements bears to the full value of the said erroneous assessment. Said reinstated tax shall be placed upon the current tax lists in the office of the county treasurer and if not paid prior to the first Monday in January of the following year, shall be subject to judgment with the delinquent taxes for the current or other years.

**Section 4.** This act shall take effect and be in force from and after its passage.

CHAPTER 444—H. F. No. 1231

*An act prohibiting barter, trade or exchange of prison made goods.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. Barter and exchange of prison made goods prohibited.**—That no goods, wares or merchandise manufactured, produced or mined, wholly or in part by convicts or prisoners (except convicts or prisoners on parole or probation), or in any penal and/or reformatory institutions in this or any other state shall be bartered, traded or exchanged by such penal institutions for any other goods, wares or merchandise of any kind whatsoever for use in such penal institutions.

**Section 2.** This act shall take effect and be in force from and after its passage.

CHAPTER 445—S. F. No. 1315

*An act providing for the creation of a park in the town of Oronoco, in Olmsted county, Minnesota, and appropriating money therefor.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Park at Oronoco created.**—That the town of Oronoco in Olmsted County, Minnesota, is hereby authorized and directed to acquire by purchase or by condemnation in the name of the state the following described tract or parcel of land lying and being in the County of Olmsted and State of Minnesota, to-wit:

The East Half of the Southeast Quarter of the Southeast Quarter of Section Seven in Township One Hundred Eight North of Range Fourteen West,

together with that part of the West Eighty-five acres of the Southwest Quarter of Section Seven in said township essential for the purpose of flowage rights that may be within the line of overflow of the waters of the proposed dam now under construction, and more particularly that part thereof beginning at a point on the west side of Minnesota Street in the village of Oronoco where the same intersects with the Zumbro River.

Section 2. **Shall be known as Oronoco Park.**—That the above described lands, when acquired, shall constitute a park to be known as "Oronoco Park" and shall forever remain for the perpetual use of the people of the state as a park, under such restrictions as may be provided by law.

Section 3. **Appropriation.**—That there is hereby appropriated out of any moneys in the State Treasury not otherwise appropriated, the sum of \$7,500 or so much thereof as may be necessary, for the acquisition of said lands.

#### CHAPTER 446—H. F. No. 1333

*To assist disabled American veterans of the World War to secure compensation and benefits they are entitled to from the United States Government.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Soldiers, sailors and marines entitled to same privileges as other veterans.**—That the soldiers, sailors and marines who were disabled in military service during the World War and their dependents, are entitled to the same privileges as are now enjoyed by all other veterans.
