herein shall include all other protected wild quadrupeds and wild birds.

- (C) Every license shall have printed thereon the kind thereof and the name of all wild animals which may lawfully be taken thereunder, and shall entitle the person to whom issued to take the wild animals therein specified in such manner and at such times and places as may be permitted by law. Protected wild animals may be taken under a hunting license only by hunting with a firearm or other lawful weapon. Protected fur-bearing animals may be taken under a trapping license only with lawful traps. Fish may be taken under fishing license only by angling, or by spearing, or netting by residents only, when possessing the required additional license so to do.
- (D) All persons who engage in selling bait to be used for fishing shall be designated as bait dealers."

CHAPTER 448-H. F. No. 1426

An act fixing the time of holding general terms of the District Court for the Fourteenth Judicial District.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Terms of District Court in the fourteenth judicial district.—The general terms of the District Court in the several counties constituting the Fourteenth Judicial District of the State of Minnesota shall be held, each year, at the times herein prescribed as follows:

Pennington County: On the fourth Monday in February and the first Monday in October.

Mahnomen County: On the fourth Monday in May.

Kittson County: On the fourth Monday in March, and the second Monday in November.

Roseau County: On the second Monday in April, and the fourth Monday in October.

Marshall County: On the first Monday in May, and the fourth Monday in November.

Norman County: On the fourth Monday in April, and the third Monday in October.

Polk County: On the third Monday in May, and the third Monday in November.

Red Lake County: On the second Monday in April, and the second Monday in October.

Section 2. Inconsistent acts repealed.—That part of Mason's Minnesota Statutes 1927, section 162, inconsistent herewith, is hereby repealed.

Section 3. Effective June 1, 1937.—This act shall take effect and be in force from and after June 1, 1937.

CHAPTER 449-H. F. No. 1433

An act relating to the salaries of certain county officials in certain counties, and repealing inconsistent acts.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salary of county treasurer in certain counties.— In all counties of this state now or hereafter having not more than 40 nor less than 39 full or fractional townships and an assessed valuation, exclusive of monies and credits, of not less than \$4,500,000, nor more than \$4,600,000 and a population, according to the last Federal census of not less than 9,500 nor more than 9,800 the following county officers shall receive the following salaries:

County Treasurer \$2250.00

- Section 2. Clerk hire for county treasurer in certain counties.—There shall be allowed for clerk hire in the office of the county treasurer a sum not to exceed \$1155.00.
- Section 3. Inconsistent acts repealed.—All acts or parts of acts inconsistent herewith are hereby repealed.
- Section 4. This act shall take effect and be in force from and after its passage.
