Accounts and Deposits.—The State Treasurer shall be ex officio the treasurer and custodian of the fund, who shall administer such fund in accordance with the directions of the commission and shall issue his warrants upon it in accordance with such regulations as the commission shall prescribe. He shall maintain within the fund three separate accounts; (1) a clearing account, (2) an unemployment trust fund account, and (3) a benefit account. All moneys payable to the fund, upon receipt thereof by the commission, shall be forwarded to the treasurer who shall immediately deposit them in the clearing account. Refunds payable pursuant to section 14 of this Act may be paid from the clearing account upon warrants issued by the treasurer under the direction of the commission. After clearance thereof, all other moneys in the clearing account shall be immediately deposited with the Secretary of the Treasury of the United States of America to the credit of the account of this State in the unemployment trust fund, established and maintained pursuant to section 904 of the Social Security Act, as amended, any provisions of law in this State relating to the deposit, administration, release, or disbursement of moneys in the possession or custody of this State to the contrary notwithstanding. The benefit account shall consist of all moneys requisitioned from this State's account in the unemployment trust fund, and shall be used exclusively for the payment of benefits as provided in this Act. Except as herein otherwise provided, moneys in the clearing and benefit accounts may be deposited by the treasurer, under the direction of the commission, in any banks or public depository in which general funds of the State may be deposited, but no public deposit insurance charge or premium shall be paid out of the fund. The treasurer shall give a separate bond conditioned upon the faithful performance of his duties as custodian of the fund in an amount fixed by the commission and in a form prescribed by law or approved by the Attorney General. Premiums for said bond shall be paid from the administration fund."

CHAPTER 453—S. F. No. 1528

An act to appropriate money for the payment of claims against the State of Minnesota; to provide for tax and other refundments; to provide for the reimbursement and compensation of certain employees of the state having claims for personal injuries sustained or for loss or damage of property incurred while engaged in the performance of their duties and for the relief of dependents of

certain employes of the state for the death of such employees while engaged in the performance of their duties; to provide for the reimbursement and compensation of persons for injuries sustained or for loss or damage to property by certain employees of the state while engaged in the performance of their duties; and by inmates of state institutions; and for relief of dependents of certain employes of the state while engaged in the performance of their duties; and to provide for payments to certain persons for services performed to the state; to authorize the state auditor to cancel certain land and other contracts heretofore entered into by certain persons with the state and to credit payments heretofore made upon other purchases or to refund the same; to reimburse certain persons for deeds to certain land erroneously conveyed by the state; to authorize the auditor to credit on certain land contracts the value of improvements found not to be on said land; to provide money for carrying on certain state activities as authorized by law; to authorize and direct certain claims to be paid out of the Game and Fish Department funds: to authorize and direct certain claims to be paid out of the Rural Credits Department funds; to authorize and direct certain claims to be paid out of the State Agricultural Society fund; to authorize and direct certain claims to be paid out of the Adjutant General's funds; and for other purposes out of other funds; and reappropriating certain balances.

Be it enacted by the Legislature of the State of Minnesota:

CHAPTER 454—S. F. No. 1531

An act requesting and directing payments to be made out of the Trunk Highway fund to compensate and reimburse the Secretary of State, a certain borough, persons, firms, or corporations, for property damaged by the location, construction, reconstruction, improvement and maintenance of the Trunk Highway system, including certain reimbursements for loss of wages to Highway Department employe, reimbursement for moneys expended by Highway Department employes in defending a law suit arising out of the construction of a Trunk Highway, reimbursement to Secretary of State for losses on uncollectible checks and counterfeit currency received for motor vehicle license plates.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Commissioner of highway to pay claims from trunk highway fund.—The Commissioner of Highways is requested and directed upon receiving receipt and discharge in full
