#### CHAPTER 5—S. F. No. 84

*An act to amend Mason's Minnesota Statutes of 1927, Section 162, relating to the holding of general terms of the District Court in the Sixth Judicial District of the State of Minnesota.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Terms of District Court in Sixth Judicial District.**—That Mason's Minnesota Statutes of 1927, Section 162, be, and the same hereby is amended to read as follows:

"162. The general terms of the District Court in the several counties constituting the Sixth Judicial District of the State of Minnesota shall be held at the time herein prescribed, as follows:

Blue Earth County: *First Tuesday in February; second Tuesday in May; second Wednesday in October.*

Watonwan County: *Second Tuesday in April; second Tuesday in September.*

Sec. 2. **Effective September 1, 1937.**—This Act shall take effect and be in force from and after September 1, 1937."

#### CHAPTER 6—S. F. No. 92

*An act to amend Laws 1921, Chapter 357, Section 1, being an act to provide for county school tax levies in certain counties.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **County school tax levy authorized.**—That Laws 1921, Chapter 357, Section 1, be and the same hereby is amended to read as follows:

"Section 1. In every county in this State in which the assessed valuation of real and personal property, exclusive of monies and credits, exceeds \$200,000,000 and the total territory of each such

counties exceeds 5,000 square miles, the County Auditor shall annually on or before the 10th day of October make a special county school tax levy not to exceed eight tenths of one-mill upon all taxable property in the county which tax and the proceeds thereof shall be apportioned by the County Auditor of each such counties among the school districts of the county as follows:"

#### CHAPTER 7—S. F. No. 111

*An act fixing the salary and compensation of the Judge of Probate in all counties now or hereafter containing not less than 16, and not more than 18 whole or fractional townships, which has an area of not less than 500 square miles or more than 600 square miles, and now or hereafter having an assessed valuation, including money and credits, of not less than \$8,000,000 and not more than \$11,000,000 and which counties now have or may hereafter have a population of not less than 17,000, and not more than 19,000 inhabitants, according to the census last taken, and repealing inconsistent acts.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salary of Probate Judge in certain counties.—The annual salary of the Judge of Probate in any county of this State now or hereafter containing not less than 16, and not more than 18 whole or fractional townships, which has an area of not less than 500 square miles or more than 600 square miles, and now or hereafter having an assessed valuation, including money and credits, of not less than \$8,000,000 and not more than \$11,000,000, and which counties now have or may hereafter have a population of not less than 17,000, and not more than 19,000 inhabitants, according to the census last taken, the salary of the Judge of Probate shall be as hereinafter provided by this act.

Sec. 2. Fixing amount of salary.—The salary of the judge of probate of any such county shall be \$2,400.00 per annum, in full compensation for all services performed for any such county as Probate Judge, except such fees as are provided by law, and shall be paid in the same manner as the salaries of other employees in said county are paid.

Sec. 3. All acts or parts of acts inconsistent herewith are hereby repealed.
