

CHAPTER 220—H. F. No. 678

An act authorizing the county auditor of Hennepin county to cancel a certain statement of payment of unredeemed lands and return amount paid thereon to purchaser.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. County auditor of Hennepin County to refund money in certain cases.—The county auditor of Hennepin County is hereby authorized to cancel a statement of payment issued to a purchaser of unredeemed lands, namely; Gust Albin Jackson, on April 19, 1938, in the amount of \$207.50 and covering land described as follows: commencing at a point on the west line of lot seven distant 191 feet south from the south line of 26th avenue northeast, thence south 37 feet, etc., being lot seven, Gale and Hamline out lots to the city of Minneapolis; and to return said property to the unredeemed lands list and refund to Gust Albin Jackson \$207.50 out of the forfeited tax sale fund and to deduct from any money that may thereafter be payable to the state and all local agencies the portion that the state and such agencies received on account of said payment, by reason of the fact that Gust Albin Jackson bid on and bought this land at public auction of forfeited lands held on April 19, 1938, after receiving and relying upon information from a public official that this land immediately joined property he already owned, when in truth and in fact it was located at a considerable distance from his property.

CHAPTER 221—H. F. No. 708

An act fixing and regulating the salary and compensation, and duties of the county auditor in any county having, or which may hereafter have, a population of 380,000 inhabitants or over, providing for deputies, clerks and other assistants in the office of such county auditor, and fixing and regulating their compensation and duties; and to amend Laws 1921, Chapter 133, Section 8, as amended; and to repeal inconsistent acts.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Salaries of deputies and clerks in the office of County Auditor in certain counties.—Laws 1921, Chapter 133, Section 8, as amended by Laws 1923, Chapter 419, by Laws

1925, Chapter 398, by Laws 1927, Chapter 426, by Laws 1931, Chapter 271, and by Laws 1937, Chapter 257, is hereby amended so as to read as follows:

"Section 8. The county auditor shall appoint and employ one chief deputy, who shall be paid the sum of \$3,600, per annum; one chief accountant who shall be paid the sum of \$3,000 per annum; one-half of which salary shall be paid from the road and bridge fund; one deputy, who shall act as clerk to the County Board who shall be paid the sum of \$3,000 per annum; one warrant deputy who shall be paid the sum of \$2,500 per annum; one draftsman who shall be paid the sum of \$2,400 per annum; two assistant draftsmen who shall each be paid the sum of \$2,300 per annum; one warrant deputy who shall be paid the sum of \$2,300 per annum; one head counter deputy who shall be paid the sum of \$2,400 per annum; *eight* counter deputies who shall each be paid the sum of \$2,200 per annum; *two* settlement clerks who shall *each* be paid the sum of \$2,300 per annum; *four special* clerks who shall each be paid the sum of \$2,200 per annum; three special clerks who shall each be paid the sum of \$2,100 per annum; two book-keepers who shall each be paid the sum of \$2,200 per annum; *four* special clerks who shall each be paid the sum of \$2,000 per annum; four senior clerks who shall each be paid the sum of \$1,900 per annum; *12* general clerks who shall each be paid the sum of \$1,800 per annum; *six* junior clerks who shall each be paid the sum of \$1,500 per annum; *one division clerk who shall be paid the sum of \$2,200 per annum; two accounting clerks who shall each be paid the sum of \$1,700 per annum; three clerks who shall each be paid the sum of \$1,200 per annum.*"

CHAPTER 222—H. F. No. 806

An act amending Mason's Minnesota Statutes of 1927, Section 4758, and amending the 1938 Supplement to Mason's Minnesota Statutes of 1927, Section 4759, relating to railroad clearances and the penalty for violation thereof.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Railroad clearances.**—That Mason's Minnesota Statutes of 1927, Section 4758, be amended so as to read as follows:
