

CHAPTER 105—S. F. No. 680

An act authorizing certain counties to issue master warrants.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Certain counties may issue master warrants.—The County Board of Commissioners in any county in the State of Minnesota, now or hereafter having a population of not less than 39,000 nor more than 41,000 according to the 1940 federal census, and containing a city of the third class and a city of the fourth class contiguous to a city of the first class lying in another county, may by resolution authorize the county auditor of said county to issue master warrants or certificates of indebtedness for the purpose of funding warrants of said county outstanding as of June 1, 1941 and interest thereon.

Sec. 2. Rate of interest—sale.—That said master warrants or certificates of indebtedness shall bear interest at the rate of not more than two per cent (2%) and shall be offered for sale in such manner as said County Board of Commissioners shall prescribe, but said master warrants shall not be sold or offered for sale for an amount less than their face value.

Sec. 3. Tax levy to retire warrants.—The County Board of Commissioners are hereby authorized to levy taxes for the purpose of retiring and paying the said master warrants or certificates of indebtedness. Said tax shall not exceed two (2) mills upon real and personal property.

CHAPTER 106—S. F. No. 681

An act to authorize the board of county commissioners to have real estate tract indexes recopied and to provide for payment for such services in certain counties.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. County board to have tract index copied in certain counties.—In all counties of this state containing not less than twelve nor more than fourteen full or fractional congressional townships with a population of not less than eighteen thousand nor more than twenty thousand inhabitants accord-

ing to the last federal census and having an assessed valuation, exclusive of moneys and credits, of not less than nine million nor more than eleven million dollars, now having tract indexes of the records in the Office of the Register of Deeds, the county board is hereby authorized to have such tract indexes transcribed, compared with the original records and checked back whenever the necessity therefor appears.

Sec. 2. **Register of deeds to supervise work.**—The work provided for in Section 1 of this act shall be performed by the Register of Deeds of the county or under his supervision. The Register of Deeds or other person performing said work shall receive as compensation therefor such sum as may be fixed by the Board of County Commissioners not exceeding five cents per line, compared with the original records and checked back.

Sec. 3. This act shall take effect and be in full force from and after passage.

CHAPTER 107—S. F. No. 705

An act to establish February 15th as "Susan B. Anthony Day."

WHEREAS, the 15th day of February, 1820, is the day in American history of the birth of Susan B. Anthony, and

WHEREAS, during her span of adult life she was a teacher and leader for righteous and noble endeavor in our country, and courageously fought for equal rights for American women and woman suffrage, and by her high and noble efforts she has been recognized as one of the outstanding liberators of American women;

NOW, THEREFORE,

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Susan B. Anthony Day established.**—That the 15th day of February of each year is hereby designated as "Susan B. Anthony Day," and whenever it does not occur on a school day the first preceding school day shall be observed in all public schools as "Susan B. Anthony Day." On such day, the United States flag shall be appropriately displayed on all
