

CHAPTER 138—S. F. No. 618.

An act relating to tax levy for revenue purposes in certain counties and providing for such tax levy to be in excess of present limitations.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Tax levy for revenue purposes in certain counties.**
--In any county in this state now or hereafter having a taxable valuation in excess of \$11,000,000 and less than \$13,000,000, and containing more than 20,000 and less than 30,000 inhabitants, and containing less than 23 full and fractional congressional townships, and containing a land area of over 700 square miles, the board of county commissioners may levy for general revenue purposes in excess of the legal limitations on such counties not more than one mill.

Sec. 2. This act shall be in effect until April 1st, 1945.

CHAPTER 139—H. F. No. 58.

An act relating to salaries of certain county officials in counties of designated area, assessed valuations and population; amending Laws 1941, Chapter 208, Sections 1, 2, 3, 4, 5, 8, 9, and 10.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Law amended.**—Laws 1941, Chapter 208, Section 1, is amended to read as follows:

Section 1. **Salary of County Auditor in certain counties.**—In all counties now or hereafter having an area of not less than 35 nor more than 55 full and fractional congressional townships and having an assessed valuation of not more than \$2,000,000 exclusive of money and credits and a population of not more than 7,000 nor less than 5,000 inhabitants, the county auditor shall receive a salary of \$1,950 per annum, in addition to all fees now or hereafter allowed by law.

Sec. 2. **Law amended.**—Laws 1941, Chapter 208, Section 2, is amended to read as follows:

Sec. 2. **Salary of County Treasurer in certain counties.**—The county treasurer of any such county shall receive a salary of

\$1,650 per annum, in addition to all fees now or hereafter allowed by law.

Sec. 3. **Law amended.**—Laws 1941, Chapter 208, Sec. 3, is amended to read as follows:

Sec. 3. **Salary of Register of Deeds in certain counties.**—The register of deeds of any such county shall receive as compensation for his services the sum of \$1,650 per annum, payable in equal monthly installments. All fees received by him shall be deposited with the county treasurer, exclusive of fees received for preparing abstracts of title, such fees shall be retained by him in addition to his compensation.

Sec. 4. **Law amended.**—Laws 1941, Chapter 208, Sec. 4, is amended to read as follows:

Sec. 4. **Salary of Clerks of District Court in certain counties.**—The clerks of the district courts in any such counties shall receive as compensation for their services the sum of \$1,650 payable in equal monthly installments. All fees due for services in the performance of their official duties shall be collected by them and deposited with the county treasurer.

Sec. 5. **Law amended.**—Laws 1941, Chapter 208, Section 5, is amended to read as follows:

Sec. 7. **Salary of County Attorney in certain counties.**—The county attorney in any such county, shall receive as compensation for his services the sum of \$1,350 per annum.

Sec. 6. **Law amended.**—Laws 1941, Chapter 208, Section 8, is amended to read as follows:

Sec. 8. **Salary of County Superintendent of Schools in certain counties.**—The superintendent of schools of any such county shall receive as compensation for his or her services the sum of \$1,350 per annum, in addition to all fees now or hereafter allowed by law.

Sec. 5. **Law amended.**—Laws 1941, Chapter 208, Section 9, is amended to read as follows:

Sec. 9. **Salary of Judge of Probate in certain counties.**—The judge of probate of any such county shall receive compensation for his services in the sum of \$1,230 per annum and, in addition to the above sum all fees collected by him.

Sec. 8. **Law amended.**—Laws 1941, Chapter 208, Section 10, is amended to read as follows:

Sec. 10. Salary of County Board in certain counties—traveling expense.—The county commissioners of any such county shall receive a salary of \$480.00 per annum; provided, that for services on the committee work the said members shall receive in addition to the above salary the compensation now provided by law.

Each member of such county boards shall also receive his actual and necessary traveling expenses, incurred in the performance of his official duties, to be audited and allowed as other claims against the county. All claims for such expenses shall state clearly the nature of the services in which same were incurred and the date of same, and all claims for expenditures for \$1.00 or over shall be accompanied by a receipt signed by the person to whom the money was paid. Provided, when a member of such county board furnishes his own conveyance for necessary travel in the discharge of his official duties he shall be entitled to charge at the rate of five cents per mile therefor.

CHAPTER 140—H. F. No. 301.

(AMENDING SECTION 376.20 MINNESOTA STATUTES 1941.)

An act relating to county tuberculosis sanatoriums: amending Mason's Minnesota Statutes of 1927, Section 695.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Law amended.—Mason's Minnesota Statutes of 1927, Section 695, is amended to read as follows:

695. Sanatorium Commission to fix amount necessary for maintenance—3 mill limitation.—The county sanatorium commission shall determine by resolution each year prior to July 1st, the amount of money necessary for the maintenance of such sanatorium during the following year and a certified copy of such resolution shall be forthwith forwarded to the board or boards of county commissioners, and such board or boards shall at the regular meeting in July include the properly approved and apportioned amount in the annual levy of county taxes. In no case shall the amount of such levy in any one year exceed two mills on the dollar of assessed valuation, *except in counties having an assessed valuation of not less than \$4,000,000 and not more than \$7,000,000, exclusive of monies and credits, and a population of not less than 14,000 nor*
