

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Law repealed.**—Mason's Minnesota Statutes of 1927, Section 2684-8, is hereby repealed.

CHAPTER 372—S. F. No. 269.

*An act fixing the salaries of certain county officers and of the county commissioners in certain counties.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Salaries of county officers in certain counties.**—In any county in this state having not less than 10 nor more than 12 organized townships and a population of not less than 16,000 and not more than 17,000 inhabitants according to the United States Census of 1940, the salary of the county auditor shall be \$2,500 per year plus fees, the salary of the county treasurer shall be \$2,500 per year, and the salary of each county commissioner shall be \$480 per year.

Sec. 2. **Inconsistent acts repealed.**—All acts or parts of acts inconsistent herewith are hereby amended or repealed.

CHAPTER 373—S. F. No. 635.

*An act authorizing payment for services rendered in the payment of rural credit bonds, rural credit certificates of indebtedness, trunk highway bonds, and interest coupons thereon.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Payment for certain services authorized.**—Payment is hereby authorized to the Bankers Trust Company of New York, New York, for services heretofore rendered and to be hereafter rendered as paying agent for the State of Minnesota in the payment of Rural Credit bonds, Rural Credit certificates of indebtedness, Trunk Highway bonds and interest coupons on such bonds and certificates, commencing with such services rendered on

and subsequent to January 1, 1942, such payment not to exceed one-tenth of one per cent on the principal amount of such bonds and certificates of indebtedness so paid, and four cents for each interest coupon so paid. Such payment shall be made from the Rural Credit Expense Fund in the case of Rural Credit bonds, certificates and interest coupons, and from the Trunk Highway Fund in the case of Trunk Highway bonds and interest coupons. The necessary sums are hereby appropriated from said funds, respectively.

CHAPTER 374—S. F. No. 638.

(AMENDING SECTION 41.02 MINNESOTA STATUTES 1941.)

*An act relating to the conservator of rural credit, fixing his salary and amending Mason's Supplement 1940, Section 6031, Subdivision B.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Law amended—Department of Rural Credit—Salary of Conservator.**—Mason's Supplement 1940, Section 6031-b, is amended to read as follows:

“(b) The Conservator shall be a person well qualified to perform the duties of the office, shall be appointed by the Governor, by and with the advice and consent of the Senate, for a term of six years at an annual salary of \$4,500 payable in semi-monthly installments, and may be removed for cause after notice and hearing on the charges made against him. He shall before entering upon his duties take and subscribe the oath prescribed by law and give a bond to the State in the sum of \$25,000 or such larger sum as the Governor may at any time determine to be necessary to indemnify the State against loss, which bond shall be conditioned, approved and filed as now provided by law.”

CHAPTER 375—S. F. No. 832.

*An act authorizing the city council or other governing body of any city of the first class in the state to fix the salary of the chief or head of the fire department of any such city.*
