

Minnesota Statutes of 1927, Section 9, as amended by Laws 1929, Chapter 65, Section 1.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Law amended.—Mason's Minnesota Statutes of 1927, Section 9, insofar as it relates to the boundaries of the thirtieth Legislative District, is amended to read as follows:

Thirtieth District.—The thirtieth district shall be composed of all that part of the fourth ward lying north of Franklin Avenue; and the twelfth, thirteenth, and fourteenth precincts of the sixth ward, all in the City of Minneapolis and shall be entitled to elect one senator and two representatives.

Sec. 2. Law amended.—Mason's Minnesota Statutes of 1927, Section 9, insofar as it relates to the boundaries of the Thirty-first Legislative District, is amended to read as follows:

Thirty-first District.—The thirty-first district shall be composed of the sixteenth, seventeenth, eighteenth, nineteenth, twentieth, twenty-first, twenty-second, twenty-third, twenty-fourth, twenty-fifth, twenty-sixth, twenty-seventh, twenty-eighth, twenty-ninth, thirtieth, thirty-first, thirty-second, and thirty-third precincts of the fifth ward and the first, second, third, fourth, fifth, sixth, seventh, eighth, ninth, tenth and eleventh precincts of the sixth ward of the city of Minneapolis and shall be entitled to elect one senator and two representatives.

Sec. 3. Law amended.—Mason's Minnesota Statutes of 1927, Section 9, as amended by Laws 1929, Chapter 65, Section 1, insofar as it relates to the boundaries of the Thirty-second Legislative District, is amended to read as follows:

Thirty-second District.—The thirty-second district shall be composed of the seventh, eighth and eighteenth precincts of the seventh ward and the first, second, third, fourth, fifth, sixth, seventh, eighth, ninth, nineteenth, twenty-sixth and twenty-seventh precincts of the eleventh ward and all of the twelfth ward of the city of Minneapolis, and shall be entitled to elect one senator and two representatives.

CHAPTER 523—H. F. No. 1160.

An act relating to taxation and authorizing additional tax levies in case of reductions of assessed valuations in certain cases.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Additional tax levies in certain municipalities.—Whenever the assessed valuation of any city, village, township or school district for any taxable year is reduced after the taxes for such year have been spread by the county auditor and whenever the mill rate as determined by the county auditor based upon the original assessed valuation is applied upon such reduced valuations and does not produce the full amount of taxes as actually levied and certified for such taxable year upon the original assessed valuations, such city, village, township or school district may include in its tax levy made following such reduction in assessed valuation, an amount equal to the difference between the total amount of taxes actually levied and certified for such taxable year upon the original assessed valuation, not exceeding the maximum amount which could be raised upon such assessed valuation as reduced, within existing mill limitations, if any, and the amount of taxes collected for such taxable year upon such reduced valuations.

Sec. 2. To be additional levy.—The amount of taxes so included shall be levied separately and shall be levied in addition to all limitations permitted by Mason's Supplement 1940, Section 2061, as amended by Laws 1941, Chapter 543, Section 1, as other applicable laws limiting levies in cities, villages, towns or school districts.
