

Such county, city, village, or borough, or official or agency thereof, may at any time sell such obligations purchased pursuant to this act, and the money received from such sale and the interest and profits or loss on such investment shall be credited or charged, as the case may be, to the fund from which the investment was made. *Neither such official nor agency, nor any other official responsible for the custody of such funds shall be personally liable for any loss so sustained.* Any such obligation may be deposited for safe-keeping with any bank or trust company.

CHAPTER 533—S. F. No. 101.

(AMENDING SECTION 271.01 MINNESOTA STATUTES 1941.)

*An act relating to the Board of Tax Appeals, amending Mason's Supplement 1940, Section 2362-10, Subdivision (d.)*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Law amended—compensation of members of board of tax appeals.**—Mason's Supplement 1940, Section 2362-10, subdivision (d) is hereby amended to read as follows:

“(d) Each member of the board shall receive \$25 per day for time spent in the performance of his duties, but not exceeding *compensation for 150 days* in any calendar year, or a proportionate amount for a fraction of a year. He shall also receive his actual and necessary expenses paid or incurred in the performance of his duties.”

CHAPTER 534—S. F. No. 190.

(AMENDING SECTION 100.055 MINNESOTA STATUTES 1941.)

*An act relating to wild animals and to illegal transportation of deer, amending Laws 1941, Chapter 498, Section 1.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Law amended.**—Laws 1941, Chapter 498, Section 1, is hereby amended to read as follows:

**“Section 1. Use of lights in hunting big game.—**(1) No person, whether singly or as one of a group of persons, shall have in possession or under control unless unloaded and properly encased, or broken down any firearm or other implement whereby big game could be killed and at the same time throw or cast the rays of a spotlight, headlight or other artificial light on any highway or in any field, woodland or forest for the purpose of spotting, locating, hunting, catching, taking, killing or wounding any big game animal.

(2) *No person, whether singly or as one of a group of persons, shall knowingly transport, aid, or assist in transporting any big game animal which has been killed in violation of the laws relating to game and fish.”*

CHAPTER 535—S. F. No. 371.

*An act to legalize repurchases from the state of land after its forfeiture to the state for taxes.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. Repurchases of tax forfeited lands legalized.—**Where a repurchase of tax forfeited lands under Laws 1939, Chapter 283, was made prior to August 10, 1939, without compliance with the provisions of Section 2 thereof and where a deed to such repurchased land has been made by the state pursuant to such repurchase, such sale is hereby confirmed and such deed is hereby ratified and confirmed.

(AMENDING SECTIONS 168.01 AND 168.06 MINNESOTA  
STATUTES 1941.)
