

Sections 2012-4 and 2394-5, Subdivision (e), as amended by Laws 1941, Chapter 109.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Law amended.—Mason's Supplement 1940, Section 2394-5, Subdivision (e), as amended by Laws 1941, Chapter 109, is amended to read as follows:

(e) **Annual tax on cooperative associations.**—Cooperative or mutual rural telephone associations; and cooperative associations organized under the provisions of Laws 1923, Chapter 326, as amended, which are engaged in the transmission and distribution of electrical heat, light or power upon a mutual, and cooperative plan in areas outside the corporate limits of any city or village; but if any such cooperative association engages in supplying electrical heat, light or power to consumers within the corporate limits of any city, village or borough, then such association shall be subject to this tax computed on that portion of its net income which its gross receipts from consumers within such corporate limits bears to its total gross receipts.

Sec. 2. Law amended.—Mason's Supplement 1940, Section 2012-4, is amended to read as follows:

2012-4. Exemptions.—Co-operative associations organized under the provisions of Laws 1923, Chapter 326, and laws amendatory thereof and supplemental thereto and engaged in electrical heat, light or power business upon a mutual, non-profit and co-operative plan in rural areas as hereinafter defined, are hereby recognized as quasi-public in their nature and purpose. Provided, however, that such cooperative associations, which operate within the corporate limits of any village, city or borough shall be assessed on the basis of 40% of the full and true value of that portion of its property located within the corporate limits of any village, city or borough as provided for in Mason's Supplement 1940, Section 1993, as amended:

CHAPTER 644—H. F. No. 1172.

An act to appropriate money for the salaries, current expenses, buildings and improvements at the state institutions, for expenses of the division of the public institutions and certain ac-

tivities under the supervision or control of said division, and for other purposes; to appropriate money from the state prison revolving fund for current expenses of the state prison; to authorize the transfer of funds in certain cases; and to authorize the commissioner of administration to make certain transfers from certain funds.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Appropriation for public institutions.—The sums hereinafter named, or so much thereof as may be necessary, are hereby appropriated from the general revenue fund in the state treasury, not otherwise appropriated, to be expended by the Division of Public Institutions for the purposes specified in the following sections of this act, to be available at the time designated opposite each item.

Provided that the Division of Public Institutions may, with the consent and approval of the Commissioner of Administration, transfer the balance of any appropriation made for a specific purpose at any institution to an account for any other specific purpose in and about such institution after the purpose for which such appropriation was made has been accomplished; and

Provided, further, that for the years ending June 30, 1944, and June 30, 1945, respectively, the Division of Public Institutions is authorized, by and with the approval of the State Auditor, to transfer in case of necessity a portion of the funds appropriated for the current expense of any one of the following institutions, namely: The Anoka State Hospital, the Moose Lake State Hospital, the Hastings State Hospital, the Willmar State Hospital, the Fergus Falls State Hospital, the Rochester State Hospital, the St. Peter State Hospital, the School for Feeble-minded, the Colony for Epileptics, the Braille and Sight Saving School, the School for the Deaf, the State Training School, the Home School for Girls, the State Reformatory, the State Reformatory for Women, and the Hospital for Crippled Children, to the use of any other of the aforesaid institutions; and

Provided, further, that said Division of Public Institutions is hereby authorized and empowered to set aside a portion of the current expense fund of any such institution to be used as a diversified labor fund for the introduction and encouragement of such industries as in its judgment may be beneficial to the inmates of such institutions; and

Provided, further, that the amounts provided for each of the fiscal years for the emergency contingent fund for state institutions as provided in this section shall be used exclusively for emergency purposes for current expenses, repairs of buildings, or emergency construction, and shall be authorized by the Commissioner of Administration after a full hearing and such amounts may be transferred from such emergency contingent fund only upon authority of the Commissioner of Administration to such institutions as provided in this act.

Sec. 20. Salary increases for duration.—Every regular, full time employee in the classified service, except department heads, whose salaries are paid from the appropriations herein made, shall receive a war salary increase of 5% of his regular base salary, plus \$7.50 per month, on July 1, 1943, to continue until the end of the second month after the cessation of hostilities in the present war, as declared by proper Federal authority; provided that no war salary increase shall exceed the sum of \$15.00 per month, and provided, further, that said war salary increase shall not be calculated upon any war salary increase received by any employee on the effective date of this act, but shall be calculated upon the regular base salary of said employee without regard to existing war salary increase of said employee. The minimum base salary payable from such appropriations shall be \$80.00 per month. Necessary revisions of salary schedules by the Civil Service Board to provide adequate and equitable salaries for position classifications within such agencies or departments are hereby authorized; the appropriations herein made include provision therefor.

Sec. 21. Unobligated balances cancelled into general revenue fund.—The unobligated balances on hand as of June 30, 1943, June 30, 1944, and June 30, 1945, in the several appropriations and accounts for each and all of the institutions named, the Division of Public Institutions and several divisions and activities of said division, for which an appropriation is made herein out of the general revenue fund, are hereby cancelled into said general revenue fund as of June 30, 1943, June 30, 1944, and June 30, 1945, together with any unobligated balance in the state institutions contingent fund of the Division of Public Institutions, excepting that any balance remaining in the Emergency Fund for State Institutions on June 30, 1944, shall not cancel but shall be reappropriated and added to the emergency fund for state institutions for the year ending June 30, 1945.

Sec. 22. All receipts deposited in general revenue fund—exceptions.—Excepting the income from the Swamp Land Trust Fund, all receipts of said institutions and activities carried on under the direction of said Division of Public Institutions shall

be deposited in and for the benefit of the general revenue fund, provided, however, that this shall not apply to revolving funds now established in said institutions; and provided further that this shall not apply to money received in payment for the services of inmate labor employed in the industries carried on at the State Reformatory, State Reformatory for Women and State Prison, which receipts shall be credited to the current expense funds of said institutions.

Sec. 23. Division to negotiate for grants.—The Division of Public Institutions is authorized and directed to negotiate with the Federal Government, or any agency, bureau or department thereof, for the purpose of securing or obtaining any grants or aid in the construction of the buildings, or the making of the improvements, authorized by this act. Any grants or aid thus secured or received are hereby appropriated to said Division of Public Institutions and made available for the uses and purposes for which it was received and shall be used in conjunction with the appropriations hereinbefore provided.

CHAPTER 645—H. F. No. 1185.

(AMENDING SECTION 80.29 AND 80.37 MINNESOTA STATUTES 1941.)

An act relating to the sale of warehouse receipts for the storing of liquor; amending Mason's Supplement 1940, Sections 3996-36, 3996-37, 3996-38 and 3996-39.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Law amended.—Mason's Supplement 1940, Section 3996-36, is amended to read as follows:

3996-36. Sale of liquor warehouse receipts is sale of securities.—The sale of Warehouse Receipts for the storing of liquor during the aging or processing period of liquor in a duly bonded warehouse in any state other than the state of Minnesota, is hereby declared to be a sale of securities as defined by *Mason's Minnesota Statutes of 1927, Section 3996-1*, and that the sale of such Warehouse Receipts is hereby permitted and legalized by duly licensed *dealers, brokers or agents* without having to procure a liquor license, when such liquor is not to be shipped nor imported into the
