

and regulations of this state applicable to its municipalities and other political subdivisions in such aeronautical projects, but subject to the laws of its own state in all matters relating to financing such projects.

Subd. 2. **To have same rights as local municipalities.** Such municipality or other political subdivision of an adjoining state shall have all the rights, privileges, and duties of like municipalities and political subdivisions of this state, including the right to exercise the right of eminent domain.

Subd. 3. **Reciprocal provisions.** This act shall not apply unless the laws of such adjoining state shall permit municipalities and other political subdivisions of this state to acquire, establish, construct, own, control, lease, equip, improve, maintain, operate, and otherwise control such airports, restricted landing areas, or other air navigation facilities therein, with all privileges, rights, and duties applicable to the municipalities and other political subdivisions of such adjoining state in such aeronautical projects.

CHAPTER 176—H. F. No. 778

An act relating to an advisory seed potato certification committee, amending Minnesota Statutes 1941, Sections 21.12 and 21.16.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1941, Section 21.12, is amended to read as follows:

"21.12. **Duties of commissioner; employees.** The Commissioner is hereby authorized and it is made his duty to provide the means and direct the work for the inspection, certification, promotion of quality, and creation of demand and sale of seed potatoes. He shall provide such forms as are necessary and keep a record of the work performed, and shall appoint, designate, or employ such officers, inspectors, and employees as may be deemed necessary and fix their compensation.

He shall appoint an advisory seed potato certification committee to consist of six members, each of whom shall be a

grower in Minnesota of certified seed potatoes, and shall serve without compensation, except he shall receive his traveling expenses and other expenses necessary in attending committee meetings. The term of each committee member shall be three years from July 1st following his appointment, except that of the first committee to be appointed, two members shall serve one year, two members shall serve two years and two members shall serve three years. Vacancies shall be filled by the commissioner for the balance of the vacant term. Said committee shall hold at least one meeting each year and other meetings when deemed necessary by the commissioner."

Sec. 2. Minnesota Statutes 1941, Section 21.16, is amended to read as follows:

"21.16. **Expenses.** All necessary expenses incurred in carrying out the provisions of section 21.11 to 21.20 and the compensation of officers, inspectors, and employees appointed, designated, or employed by the commissioner, as provided in sections 21.11 to 21.20, together with their necessary traveling expenses, *together with the traveling expenses of the members of the advisory seed potato certification committee, and other expenses necessary in attending committee meetings,* shall be paid from, and only from, the seed potato inspection fund, on order of the commissioner and auditor's voucher warrant."

CHAPTER 177—H. F. No. 812

An act relating to contracts for loans made on the application of war veterans under 21 years of age and guaranteed by the Administrator of Veterans' Affairs pursuant to any federal law in an amount authorized thereby.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Minority of war veterans not to affect their contracts for loans.** No contract for a loan made upon the application of any person under 21 years of age who was in the active military or naval service of the United States on or after September 16, 1940, and guaranteed by the Administrator of Veterans' Affairs pursuant to any federal law in an amount authorized thereby shall be impaired or invalidated on the ground of the minority of such person.
