

CHAPTER 476—S. F. No. 312

An act relating to change of residence by an old age assistance recipient and resulting public responsibility of county of new residence, amending Minnesota Statutes 1941, Section 256.36.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1941, Section 256.36, is amended to read:

256.36. **Change of residence of recipient.** When a recipient changes his place of dwelling he shall notify the county agency in which his old age assistance certificate is in effect. If he removes to another county he shall declare whether such absence is temporary or for the purpose of taking up regular domicile. The county originally granting old age assistance shall continue to pay the same regardless of change of residence within the state by the recipient. *Provided, however, after the period of one year, if the amount of such old age assistance is increased, then the county to which such old age recipient has moved shall pay the amount of the increase so allowed.*

Sec. 2. **Effective date.** This act shall take effect and be in force from and after July 1, 1945.

CHAPTER 477—S. F. No. 464

An act authorizing the Commissioner of Conservation to acquire lands for state park purposes and appropriate money therefor.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Commissioner may acquire land.** The Commissioner of Conservation is authorized to acquire by purchase or condemnation at a price of not to exceed an average of \$60.00 per acre, the following described lands in the County of Jackson, State of Minnesota:

Not to exceed 99 acres of timbered lands along the south bank of the Des Moines River in the Southwest quarter of Section 16, Township 103 North, Range 35 West of the fifth principal meridian, also;

Not to exceed 159 acres lying along the south bank of the Des Moines River in the East one-half ($E\frac{1}{2}$) and the North-east quarter of the Northwest quarter ($NE\frac{1}{4}$ of $NW\frac{1}{4}$), of Section 17, Township 103 North, Range 35 West of the fifth principal meridian.

Sec. 2. **Kilen Woods state park.** These lands, when acquired, shall be a state park known as Kilen Woods State Park under the supervision and control of the Commissioner of Conservation as provided for other state parks.

Sec. 3. **Appropriations.** There is hereby appropriated to the Commissioner of Conservation out of any moneys in the State Treasury not otherwise appropriated, the sum of \$15,000, or so much thereof as may be necessary for the purposes of this act.

CHAPTER 478—S. F. No. 466

An act relating to payment of wages by public service corporations; amending Minnesota Statutes 1941, Section 181.08.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1941, Section 181.08, is amended to read as follows:

181.08. **Semimonthly payments.** All public service corporations doing business within this state are required to pay their employees at least semimonthly the wages earned by them to within 15 days of the date of such payment, unless prevented by inevitable casualty. *Such wages shall be paid in cash, or by checks convertible into cash at full face value thereof, without any service, exchange, discount, float or other charges, at a bank designated by such public service corporation located in any city, village or borough in which the employee to whom the check is issued is employed or into which such employee is required to go in the performance of his work for the company issuing the same. It shall be the duty of the corporation to make necessary arrangements with a bank for the cashing of these checks without such charges, or to reim-*
