

CHAPTER 609—H. F. No. 1395

An act appropriating money from the following funds for the following purposes: From the general revenue fund for expenses of the state government, including public relief, and salaries of officers and employees thereof, and for other purposes; from the trunk highway fund for certain expenditures therefrom; from the rural credit expense fund for expenses of the rural credit department, and salaries of officers and employees thereof, and for other purposes; from the game and fish fund for expenses of the conservation department, and salaries of officers and employees thereof, and for other purposes; from the Minnesota State Building Fund for the construction, remodeling, altering or equipping of certain buildings, levying a tax to provide funds therefor, authorizing the issuance of certificates of indebtedness and the purchase thereof by the state board of investment; providing for the reimbursement from the trunk highway of certain appropriations from the general revenue fund to certain state officers and departments performing services for the state highway department, and prescribing the method thereof and procedure therefor; creating the Laws 1941, Chapter 68 revolving fund, prescribing the purposes and procedure thereof and appropriating the moneys therein for such purposes; appropriating moneys from the general revenue fund for salary increases to certain state officers and employees under certain conditions; prohibiting any funds to be expended for publicity representatives, and prohibiting any official in any state department from using any fund and fees for any purpose not contemplated by the appropriations in this act contained, making a violation thereof unlawful and cause for the immediate dismissal of the employee or official committing such violation; limiting the authority to change the amount of fees to be collected; extending and reenacting certain provisions of Laws 1941, Chapter 525; extending and reenacting certain provisions of Laws 1941, Chapter 529, extended and reenacted by Laws 1943, Chapter 617, and reappropriating certain moneys appropriated thereby; repealing certain provisions of Laws 1943, Chapter 660; repealing proviso in Laws 1941, Chapter 529, Section 1, Subdivision 11, as amended by Laws 1943, Chapter 617; and for other purposes.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Appropriations for expenses of state government. Except as herein otherwise specifically provided, the sums hereinafter set forth in the columns designated "APPROPRIATIONS," or so much thereof as may be necessary, are hereby appropriated out of the general revenue fund in

the state treasury for the purposes specified in the following sections of this act, to be available for the fiscal years indicated for each purpose. The figures "1945," "1946," and "1947," wherever used in this act, shall mean that the appropriation or appropriations listed thereunder shall be available for the year ending June 30, 1945, 1946 and 1947 respectively.

b. Overtime 125,000 125,000

For the purpose of computing payment for overtime, all employees in the Grain Inspection Division shall be compensated for each week's work on the following basis: For time worked up to 44 hours, regular salary; for time worked in excess of 44 hours but not in excess of 48 hours, compensatory time off until the employee shall have accumulated 132 hours, thereafter 1½ times regular salary, but no employee shall be entitled to carry more than 24 hours accumulated compensatory time off over into the succeeding fiscal year; for time worked in excess of 48 hours, 1½ times regular salary; for all time worked on Sundays and legal holidays, irrespective of the number of hours worked by the employee in the week, 1½ times regular salary. The Commission is authorized and directed to adjust its schedule of fees to provide that the initial charge made for services to be rendered shall be sufficient to cover all salaries, expense and overtime; the commission shall review and adjust its schedule of fees at the end of each six months so as to insure an initial charge sufficient to pay all salaries, expense and overtime during the ensuing quarter.

The amounts allocated in this subdivision are the maximum that may be used for the purposes specified except that any item may be increased by not more than 15 per cent in the event of any emergency which, in the discretion of the commissioners of conservation and administration warrants such increase.

To the maximums allowed in Items 2, 3 and 5, are added \$40,000, \$125,000, and \$70,000 respectively, or so much thereof as is necessary, for each year of the biennium, for the purpose of carrying out construction or maintenance work of the bureaus supported by those items, if material and manpower conditions permit such activities.

Item 6 shall act as a revolving fund into which moneys received from the federal government in reimbursement shall be paid. All moneys in said fund shall be available for use, and if said fund is insufficient to match the federal moneys available, it may be supplemented by transfers of dedicated receipts of the division not otherwise allocated, or, if allocated, not needed for the activity to which they are credited.

Item 4 shall act as a revolving fund to be used for all rough fish removal activities and all receipts from said activities are to be credited to said fund. Provided, at the beginning of any fiscal year if the fund is less than \$150,000, it must be supplemented by transfer from the game and fish fund of any moneys therein.

All amounts appropriated in this subdivision are to be charged against the game and fish fund and not against the general revenue fund. All receipts credited to the game and fish fund not herein authorized to be used or otherwise transferred shall be retained in the game and fish fund as a surplus.

Sec. 49. Application of salary increase provisions. Subdivision 1. The head of each department and division of the state government in the unclassified service of the state civil service, the executive secretaries of state agencies in the unclassified service except that of the state board of health, deputies in the unclassified service, assistant attorneys general and

other attorneys in the office of the attorney general, and the secretary to the governor, shall be paid for his services during the biennium ending June 30, 1947, the amount of his salary as fixed by this act or any other provision of law plus 10 per cent of such salary.

Subd. 2. The above provision of this section shall not apply to any officer or employee unless the officer or employee is paid from an appropriation made by this act, nor shall it apply to the justices of the supreme court, the judges of the district court, the governor, the lieutenant-governor, or members of the legislature.

Subd. 3. There is hereby appropriated to each officer and department to which an appropriation is made in this act, an amount sufficient to pay the increase of 10 per cent in salaries provided in Subdivision 1 of this section, which amount shall become available when the state auditor shall have transferred such additional amount to the appropriate appropriation account after certification to him by the commissioner of administration of the amount required for each ensuing fiscal year.

Subd. 4. There is hereby appropriated out of the general revenue fund the sum of \$35,000 for each of the fiscal years ending June 30, 1946 and 1947, respectively, for the purpose of carrying out the provisions of this section.

Subd. 5. For the biennium ending June 30, 1947, the director of game and fish shall receive a 10 per cent increase of his present salary, and the amount necessary for the payment thereof is hereby appropriated out of the game and fish fund.

Subd. 6. For the biennium ending June 30, 1947, the salary of the commissioner of highways shall be increased 10 per cent, the amount thereof to be paid from the trunk highway fund.

Subd. 7. The amount necessary to pay the 10 per cent increase for the conservator of rural credits provided by Subdivision 1 of this section shall be paid from the rural credits expense fund salary account.

Sec. 50. Fees. The fees fixed for the various accounts for which an appropriation is made in this act pursuant to existing authority of law shall be neither increased or decreased except with the approval of the commissioner of administration. All adjustments in fees shall be made to the end that the total fees received shall approximate the amount appropriated for the several funds.

Sec. 51. **Unobligated balances.** The unobligated balances on hand as of June 30, 1945, June 30, 1946, and June 30, 1947, in the several appropriations and accounts for each of the state departments or divisions for which an appropriation is made herein, except the accounts provided in Subdivision "G" of Section 39, and Section 45, and unless otherwise excepted in this act, are hereby cancelled into the general revenue fund for fiscal years ending June 30, 1945, June 30, 1946, and June 30, 1947, and except the balances remaining in the motor vehicle division of the Secretary of State's office, which balances are to be covered into the Trunk Highway Fund.

Sec. 52. **Income deposited in general revenue fund.** Except as herein otherwise provided, all income, including fees or receipts of any nature whatsoever, except all federal aid, contributions or reimbursements received for any account of any division or department for which an appropriation is made in this act, shall be deposited in and for the benefit of the general revenue fund.

Sec. 53. **Counties' share of state inheritance tax.** The state auditor and state treasurer are hereby authorized to set aside in a separate account the amount due the several counties as their share of the state inheritance tax under the provisions of General Laws 1911, Chapter 209, Section 21-D, and acts amendatory thereof, and to pay to the county treasurer of the several counties such amounts at the end of each fiscal year.

Sec. 54. **Misappropriation of funds.** It is hereby made illegal for any official or head of any state department or any employee thereof to use moneys appropriated by this act or fees collected for any other purpose than the purpose for which such moneys have been appropriated and any such act by any head of a department or any state official is hereby declared to be illegal and be cause for immediate removal of such official or head of a state department from the position he holds with the government of this state, or if proof is made of such charge before any judge of any district court of this state, such court may cause such official or head of a state department to be removed upon proof being duly made of the misappropriation or for any other purpose than which the appropriation was made, except in an emergency and then only with the approval of the commissioner of administration. Provided, however, that funds may be transferred to the credit of the State Employees' Retirement Fund and used for the purposes thereof, as provided by law.

Sec. 55. No publicity representatives. No state department, bureau or division, whether the same operates on funds appropriated or receipts or fees of any nature whatsoever, except the Highway Department, and Game and Fish Division, shall use any of such funds for the payment of the salary or expenses of a publicity representative. The head of any such department, bureau or division shall be personally liable for funds spent contrary to this provision. This act shall not be construed, however, as preventing any such department, bureau or division from sending out any bulletins or other publicity required by any state law or necessary for the satisfactory conduct of the business for which such department, bureau or division was created.

Sec. 56. Veterans relief. Subdivision 1. There is hereby appropriated to the Governor out of the general revenue fund in the state treasury, for such relief purposes as are described in Laws 1941, Chapter 525, the sum of \$1,110,000 for the fiscal year ending June 30, 1946, of which amount a sum not to exceed \$450,000 shall be available for veterans' relief and a sum not to exceed \$660,000 shall be available for the purpose of furnishing all other forms of public relief and assistance as provided in Laws 1941, Chapter 525, and the sum of \$1,160,000 for the fiscal year ending June 30, 1947, of which amount a sum not to exceed \$500,000 shall be available for veterans' relief and a sum not to exceed \$660,000 shall be available for the purpose of furnishing all other forms of public relief and assistance as provided in Laws 1941, Chapter 525. None of the moneys appropriated here shall be used for work relief or any works project.

The expenditures of the moneys appropriated by this section shall be subject to all the limitations and conditions imposed by Laws 1941, Chapter 525, upon the expenditures of the moneys therein appropriated and all such limitations and conditions are hereby extended and reenacted. The Minnesota Public Relief Advisory Committee is hereby continued for the purposes of this section, and all provisions of Laws 1941, Chapter 525, relating thereto are hereby extended and reenacted.

Subd. 2. Laws 1943, Chapter 660, Section 59; Subdivision 2, is hereby repealed.

Sec. 57. Reappropriation of certain moneys. Subdivision 1. All moneys appropriated by Laws 1941, Chapter 529, for purposes which have not been accomplished and remaining unexpended or unencumbered on June 30, 1945, are hereby reappropriated to the agencies of the state as therein named and

for the purposes as therein stated and are made available until such purposes have been accomplished.

Subd. 2. All other provisions of Laws 1941, Chapter 529, are hereby extended and reenacted.

Subd. 3. There is hereby appropriated for the purposes hereinafter stated from the Minnesota State Building Fund the sums of money set forth in the following subdivisions, which sums of money shall be in addition to the sums of money appropriated for such purposes by Laws 1941, Chapter 529, and reappropriated for such purposes by Laws 1943, Chapter 617.

Subd. 4. For the purpose of providing funds with which to carry out the provisions of this section, the state auditor is hereby authorized and directed to cause to be levied upon all taxable property in the state, in the manner in which other state taxes are levied, for each year commencing in the year 1945 and for each of the next succeeding six years, taxes sufficient to produce \$137,000 each year, together with such additional sum each year as may be necessary to pay the interest upon the certificates of indebtedness issued pursuant to the provisions of this act.

Subd. 5. The proceeds arising from the tax levy authorized by Subd. 4 of this section shall be credited to the fund known as the Minnesota state building fund, and said fund is hereby appropriated for the purpose of erecting the buildings authorized to be erected and making the improvements

provided for in this section and purchasing the equipment authorized by this subdivision.

Subd. 6. Pending the levy and collection of the taxes hereinbefore authorized, the state auditor is hereby authorized and empowered to issue and sell at not less than par, as funds are needed for the purposes of this section, certificates of indebtedness of the state in the aggregate of \$959,600 to be known as the University and Teachers' Colleges and Building Fund certificates of 1945, which certificates shall mature at such time not exceeding eight years from the date thereof, and shall bear interest at a rate not exceeding three per cent per annum, payable semi-annually, and shall be in such form as the state auditor may determine. Such certificates shall be signed in behalf of the state by the state treasurer and shall be attested by the state auditor under their respective seals, and the auditor and the treasurer shall keep due record thereof. The proceeds of the sale of said certificates shall be credited to the Minnesota state building fund, and the principal and interest thereof shall be paid from said fund, provided that such interest as may become due on said certificates, until said taxes have been collected to meet the same, shall be paid out of the revenue fund in the state treasury, and the amount necessary therefor is hereby appropriated to be reimbursed from the proceeds of such taxes when received. The state auditor is hereby authorized and directed to apply any moneys remaining unexpended in such fund when the provisions of this section and of Laws 1941, Chapter 529, shall have been completely accomplished to the payment of any certificates of indebtedness issued as provided by this section or by Laws 1941, Chapter 529, and to transfer the balance thereof, if any, to the general revenue fund in the state treasury.

Subd. 7. The amounts obtained from the sale of the certificates of indebtedness authorized by this section are hereby appropriated to the Board of Regents of the State University and the commissioner of administration in the respective amounts allocated to each item as hereinbefore specified and provided.

Subd. 8. The state board of investment is hereby authorized to invest the state trust funds in the certificates of indebtedness herein authorized by this section, and is hereby authorized to purchase said certificates at the rate of interest specified herein as from time to time the board has available funds for such purpose.

Sec. 58. Subdivision 1. Laws 1943, Chapter 660, Section 58, Subdivision 1, is hereby amended to read as follows:

Sec. 58. Appropriations for mechanical engineering and aeronautical building at state university; tax levy. Subdivision 1. There is hereby appropriated to the Board of Regents of the state university the sum of \$1,469,000, from the fund hereinafter created, for the purpose of constructing a Mechanical-Engineering and Aeronautical Building on the main campus of the university. *Notwithstanding any other provisions hereinafter contained in this act, the state auditor may sell and issue any certificates of indebtedness under the authority hereinafter created in this act any time without regard to the cessation of hostilities in the present war as declared by proper federal authority.*

Subd. 2. For the purpose of providing the additional funds appropriated by subdivision 1 of this section, the state auditor is hereby authorized and directed to cause to be levied upon all taxable property in the state, in the manner in which other state taxes are levied for each year commencing in the year 1946, and for each of the next succeeding four years, taxes sufficient to produce \$58,800 each year, together with such additional sum each year as may be necessary to pay the interest upon the certificates of indebtedness issued pursuant to the provisions of this section. In case of a deficiency in the proceeds of such tax levy for any year, the state auditor shall levy additional amounts in succeeding years to compensate therefor until the full amount herein authorized has been raised. The proceeds of such taxes shall be credited to the University Building Fund of 1943-1945. The state auditor is hereby authorized and directed to apply any moneys remaining unexpended in such fund when the purposes of Laws 1943, Chapter 660, Section 58 and of this section shall have been completely accomplished to the payment of any certificates of indebtedness issued as hereinafter provided and as provided by Laws 1943, Chapter 660, Section 58, and the interest thereon, and to transfer the balance thereof, if any, to the general revenue fund in the state treasury.

Subd. 3. Pending the levy and collection of such taxes, the state auditor is hereby authorized and directed to issue and sell certificates of indebtedness of the state as funds are needed for the purposes of this section and of Laws 1943, Chapter 660, Section 58, not exceeding the amount required from time to time to meet the appropriation made in Subdivision 1 of this section and not exceeding \$294,000 in the aggregate. Such certificates shall be known as the University Building Certificates of 1945-1947, shall be numbered consecutively, and shall be issued and sold at not less than par

upon sealed bids after two weeks' published notice, unless sold to the State Board of Investment, which is hereby authorized to invest any funds under its control or direction in any such certificates of indebtedness so issued and to purchase such certificates at a rate of interest not exceeding three per cent per annum. Such certificates shall be in such form and of such denominations and shall mature at such times as the state auditor shall determine, not exceeding the time when funds shall be available for the payment thereof from tax levies herein authorized. Such certificates shall bear such rate of interest payable semi-annually, and shall contain such other terms and provisions, not inconsistent herewith, as the state auditor may determine. Such certificates shall be signed by the state treasurer and attested by the state auditor under their official seals, and the state auditor and state treasurer shall keep records thereof. Such certificates shall be a charge upon and a lien against the taxes herein authorized. The principal of such certificates shall be payable only from the proceeds of such taxes, and so much thereof as may be necessary is hereby appropriated for such payments, provided, that such interest as may become due at any time when there is not on hand a sufficient amount from the proceeds of such taxes to pay the same shall be paid out of the general revenue fund, and the amount necessary therefor is hereby appropriated, to be reimbursed from the proceeds of such certificates.

Sec. 59. Duties of commissioner of administration. Subdivision 1. The commissioner of administration on or after July 1 of each year, beginning July 1, 1945, shall determine the amount of the cost of the operation during the preceding fiscal year of the following state offices and departments, to-wit: the state auditor, the state treasurer, the department of administration, the department of civil service, and the public examiner, which is attributable to the operation of the state department of highways. The amount of the cost of the several state offices and departments enumerated above attributable to the operation of the state highway department during the preceding fiscal year, hereinafter referred to as the attributable amount, shall be the amounts determined by the commissioner of administration as hereinafter provided.

Subd. 2. The attributable amount of the cost of operating the office of the state auditor shall be the amount of the salaries paid to employees who devote their entire time to highway matters plus the percentage of the amount expended for the salaries of all officers and other employees, except the employees no part of whose time is attributable to the oper-

ation of the department of highways, of the office and for all supplies and other expenses, which the total number of warrants issued by the state auditor for the department of highways plus two-thirds of the total number of warrants issued by the state auditor for refunds of gasoline taxes is of the total number of warrants issued by the state auditor for all state purposes.

Subd. 3. The attributable amount of the cost of operating the office of the state treasurer is the percentage of the amount expended for salaries, supplies, and expense of the office, which the total number of warrants accepted on account of the operation of the department of highways plus two-thirds of the total number of warrants accepted on account of refunds of gasoline taxes is of the total number of warrants accepted for all state purposes.

Subd. 4. The attributable amount of the cost of operating the department of administration shall be the total of attributable amounts determined as follows:

(1) The attributable amount of the cost of operating the division of purchases is the percentage of the amount expended for salaries, supplies, and expense of the division which the number of requisitions for purchases issued for the department of highways is of the total number of requisitions issued for all state purposes.

(2) The attributable amount of the cost of operating the office of the state printer is the percentage of the amount expended for salaries, supplies, and expense of the office, which the total number of requisitions for printing for the department of highways is of the total number of requisitions for printing issued for all state purposes.

(3) The attributable amount of the cost of the general administration of the department of administration, the budget division, and the budget engineering division is the percentage of the amount expended for salaries, supplies, and expense thereof, which the total expenditures of the department of highways is of the total expenditures for all state purposes.

Subd. 5. The attributable amount of the cost of operating the department of civil service is the percentage of the amount expended for salaries, supplies, and expense of the department, which the average number of employees of the department of highways during the year is of the average number of employees employed by the state during the year.

Subd. 6. The attributable amount of the cost of operat-

ing the office of the public examiner is amount expended by the office for salaries, supplies, and expense in connection with auditing the department of highways.

Subd. 7. When the commissioner of administration has determined the total attributable amount of the cost of the offices and departments enumerated in subdivision 1 of this section, he shall certify the amount so determined to the state auditor. The several amounts so certified by the commissioner of administration are hereby appropriated from the trunk highway fund to the general revenue fund in the state treasury as a reimbursement of moneys appropriated by this act and any act hereafter enacted appropriating money to the several state officers and departments enumerated in subdivision 1 of this section for salaries, supplies, and expense expended for services, supplies, and expense attributable to highway matters. Upon receipt of the certification of the commissioner of administration, the state auditor shall transfer from the trunk highway fund to the general revenue fund in the state treasury the amount certified by the commissioner of administration and the state auditor is authorized and directed to make the appropriate entries in the records of respective funds. The commissioner of administration shall transmit a duplicate original of the certification to the state treasurer who is authorized and directed to make the appropriate entries in his records.

Subd. 8. There is hereby appropriated from the general revenue fund in the state treasury to each of the state officers and departments hereinafter named for the fiscal year ending June 30, 1945, for the purposes hereinafter set forth the amounts opposite the named purpose:

The provisions of Laws 1943, Chapter 660, appropriating from the trunk highway fund to the state officers and de-

partments above named moneys for the purposes above named and in like amounts are hereby repealed.

Sec. 60. Certificates of indebtedness authorized. a. Whenever it becomes necessary in order to meet the current demands upon the revenue fund for the payment of warrants issued or to be issued against said fund pursuant to appropriations, the governor, after securing the recommendation of the advisory committee, which shall be advisory only, or, if there be no such committee, the governor, the state auditor and the state treasurer as a special committee, at any time prior to June 30, 1947, may authorize the issuance and sale of certificates of indebtedness of the state, payable out of said revenue fund; in such amount as may be necessary to pay such warrants; such certificates to be signed by the state treasurer, attested and recorded by the state auditor, and to be numbered serially and to be of such denomination and bear such dates of issue and of maturity and such rate of interest as the governor or such special committee shall determine; provided, that no such certificate shall mature after the current fiscal year, and provided further, that the aggregate amount of such certificates at any time outstanding shall never exceed \$5,000,000. The failure or refusal of the advisory committee, if there be one, to make a recommendation promptly shall be deemed a negative recommendation. If funds are not available to retire any such certificates at maturity, the same may be refunded by the issuance of new certificates or may be extended by agreement with the holders thereof. Certificates issued and sold pursuant to the authorization of this act shall be retired out of the receipts of the revenue fund appropriated to the payment of the warrants issued against said fund but taken up with the proceeds of such certificates. The sum of \$50,000, or so much thereof as may be necessary, is hereby appropriated and made available for the biennium ending June 30, 1947, to pay the interest upon such certificates.

b. The state board of investment, or its successor in authority, is hereby authorized to purchase the certificates of indebtedness herein authorized for any fund which it is authorized to invest, provided, it shall not purchase any such certificates bearing interest at a rate of less than one and one-half per cent per annum.

Sec. 61. Duties of state auditor. The state auditor is hereby authorized and directed to transfer to the general

revenue fund in the state treasury, all monies credited to any fund established in connection with the payment of certificates of indebtedness when the purposes for which the act authorizing such certificates has been accomplished.

Sec. 62. Transfer of certain funds. There is hereby transferred from the rural credit expense fund to the general revenue fund the sum of \$3,000 to reimburse the revenue fund for a grant by the Legislative Advisory Committee to the department of rural credits to supplement said rural credit expense fund.

Sec. 63. Maximum liability for salary increases. The amounts appropriated for salary increases herein are intended to constitute a maximum liability for that purpose in the various accounts for which such an appropriation is made, and the various officials are directed to permit salary increases in such manner that there shall be available sufficient funds for salary increase for each employee in each department in accordance with the law in relation to salary increases. Salary increases shall not be granted unless sufficient funds remain unobligated in the department by reason of previously granted salary increases, so that the liability for all salary increases, if they were to be paid for an entire fiscal year, would not exceed the funds provided for that purpose in this act.

Sec. 64. Appropriations subject to certain limitations. All the foregoing appropriations herein contained are to be expended subject to the provisions of Laws 1939, Chapter 431. No appropriation shall become available for expenditure until such estimates as required by Section 16, Article II, of such act shall have been approved by the Commissioner of Administration. No obligation involving expenditure of money shall be entered into unless there is a balance in the appropriation available not otherwise encumbered to pay obligations previously incurred.

Sec. 65. The proviso in Laws 1941, Chapter 529, Section 1, subdivision 11, as amended by Laws 1943, Chapter 617, is hereby repealed.
