

Sec. 2. Time for application limited. All applications for the extension of the terms of such mining contracts or leases must be made to the Commissioner of Conservation within six months after the effective date of this Act, and shall be in such form and contain such information as the Commissioner may prescribe.

CHAPTER 292—S. F. No. 800

An act authorizing the commissioner of conservation to sell certain swamp lands.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Sale of certain swamp lands. The commissioner of conservation is hereby authorized to sell lot 8, section 26, township 53, range 23, in the same manner as provided by law for the sale of other state swamp lands, notwithstanding the fact that such lands may lie within a state forest area or border the waters of a meandered or an unmeandered lake.

CHAPTER 293—S. F. No. 916

An act to authorize the conveyance of certain real estate now owned by the state to the city of Shakopee.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Sale of certain state lands to city of Shakopee. For and in consideration of the payment by the city of Shakopee to the state of the sum of \$7,500, the governor and state auditor shall transfer and convey by proper deed of conveyance in the name and on behalf of the state of Minnesota, to the city of Shakopee in the county of Scott in the state of Minnesota, the following described real estate situated and being in said county, to wit:

Government lots 1 and 2 of section 32; government lot 1 of section 31, township 116, range 22 and all that part of government lots 1 and 2, the northwest quarter of the northeast quarter and the northwest quarter of the northwest quarter, section 5, township 115, range 22, lying north of the north line of the state trunk highway No. 101, and all that part of government lot 6, section 6, township 115, range 22, lying north of the north line of state trunk highway No. 101, excepting therefrom the following: Starting at a point on the west line of said government lot 6, 117 feet north of the south line of First Street in Shakopee extending easterly, and running thence north 79 degrees, 30 minutes east parallel to First Street 80 feet, thence north parallel to the east line of government lot 5, 51.5 feet, thence northeasterly parallel to First Street 25.8 feet to a point 104 feet due east of the east line of government lot 5, thence north parallel to said government lot line 334 feet to the water edge of a pond, thence southwesterly along said water edge to the west line of government lot 6, thence south along said west line about 336 feet to the place of beginning, and all that part of the southeast quarter of the northeast quarter of section 6, township 115, range 22, lying south of the right of way of the Chicago, St. Paul, Minneapolis and Omaha Railroad Company, all according to the government survey thereof on file and of record in the office of the register of deeds in and for the county of Scott and state of Minnesota.

Said transfer and conveyance to be subject to the right of the State of Minnesota and its Department of Highways to remove gravel and other road materials and trees and plant materials from Government Lot 1 of Section 31, and Government Lots 1 and 2 of Section 32, township 116 north, range 22 west, the southeast quarter of the northeast quarter of Section 6, township 115 north, range 22 west, lying south of the right of way of the Chicago, St. Paul, Minneapolis and Omaha Railroad Company, and Government Lot 1 of Section 5, township 115 north, range 22 west, together with the right of ingress to and egress from Trunk Highway No. 101—187 over and across any of the lands described in this act. The rights herein reserved in the State of Minnesota to extend for a period ending five years from the date hereof as to the trees and plant materials, perpetually with reference to the rights reserved in Government Lot 2 of Section 32, township 116 north, range 22 west, and Government Lot 1 of Section 5, township 115 north, range 22 west, and until October 30, 1960, with reference to the rights reserved in the remaining lands herein described. Said transfer and conveyance to be

subject to a further right in the State of Minnesota and its Department of Highways to restrict the points of access from any of the lands described in this act to Trunk Highway 101=187 to such locations as are determined by the Commissioner of Highways.

CHAPTER 294—S. F. No. 1016
[Coded as Sections 60.581 to 60.587]

An act providing for the merger and consolidation of insurance corporations.

Be it enacted by the Legislature of the State of Minnesota:

[60.581] **Merger.** Section 1. Subdivision 1. **Domestic insurance corporations.** Any two or more domestic insurance corporations, formed for any of the purposes for which stock, mutual, or stock and mutual insurance corporations might be formed under the laws of this state, may be

(1) merged into one of such domestic insurance corporations, or

(2) consolidated into a new insurance corporation to be formed under the laws of this state.

Subd. 2. **Domestic and foreign insurance corporations.** Any such domestic insurance corporations and any foreign insurance corporations formed to carry on any insurance business for the conduct of which an insurance corporation might be organized under the laws of this state, may be

(1) merged into one of such domestic insurance corporations, or

(2) merged into one of such foreign insurance corporations, or

(3) consolidated into a new insurance corporation to be formed under the laws of this state, or

(4) Consolidated into a new insurance corporation to be formed under the laws of the government under which one of such foreign insurance corporations was formed, provided that each of such foreign insurance corporations is
