

\$50,000. The undisbursed balance in said fund in excess of \$50,000 shall be transferred at the end of each fiscal year to the general revenue fund.

CHAPTER 316—S. F. No. 110

An act relating to the law of arrest and amending Minnesota Statutes 1945, Section 629.32.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Minnesota Statutes 1945, Section 629.32, is hereby amended to read as follows :

629.32. **How made; restraint; show warrant.** An arrest is made by the actual restraint of the person of the defendant or by his submission to the custody of the officer; but he shall not be subjected to any more restraint than shall be necessary for his arrest and detention, and the officer shall inform the defendant that he is acting under the authority of a warrant, and shall show him the warrant if so required. *An arrest by a peace officer acting under a warrant is lawful even though the officer does not have the warrant in his possession at the time of the arrest, but if the person so requests the warrant shall be shown to him as soon as possible and practicable. An arrest may lawfully be made by a peace officer when advised by any other peace officer in the state that a warrant has been issued for that person.*

CHAPTER 317—S. F. No. 489

An act relating to the survey and investigation of the underground water resources of the Red River Valley, granting authority to Commissioner of Conservation to cooperate with federal government and state and local governmental agencies of the states of North Dakota, South Dakota and

Minnesota, and appropriating money therefor and amending Laws 1945, Chapter 198.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1945, Chapter 198, is hereby amended to read as follows:

Section 1. **Survey of underground water resources of Red River Valley.** The Commissioner of Conservation is authorized to enter into a cooperative agreement or agreements with the United States Government, acting through the United States Geological Survey or other authorized agency, the states of North Dakota and South Dakota, and with local governmental agencies of those states and Minnesota, *individually or collectively, to continue* a survey of the underground water resources of the Red River Valley, the United States Government, acting through the United States Geological Survey or other authorized agency, to agree to assume one-half of the cost thereof.

Sec. 2. **Appropriation.** There is hereby appropriated for this purpose to the Commissioner of Conservation, out of any moneys in the State Treasury not otherwise appropriated, the sum of \$2,500.00 for the fiscal year ending June 30, 1948. Any balances remaining unexpended at the end of the fiscal year ending June 30, 1948, shall be available for the continuation of the purposes of this Act.

Sec. 3. **Contributions.** Provided, that the amount provided in Section 2 shall not be available until there is available by contribution *a like sum of \$2,500.00 from each of the state or local governmental subdivisions cooperating.*

Sec. 4. **Local government agencies may contribute.** *The county boards and the governing bodies of the local governmental agencies are hereby authorized to appropriate money from their respective general revenue funds for the purpose of carrying out the provisions of this chapter and may accept and receive gifts therefor.*
