non-payment of taxes exclusive of those employed in the office of the Land Commissioner.

- (f) One chief deputy or principal assistant for each elected public official.
- (g) Doctors, interns, and student nurses employed by the county or any county agency.
- (h) Special police officers or special deputy sheriffs serving without pay.
- (i) District court and probate court reporters and officers and employees of county probation offices, county boys' farms, and county girls' schools.
- (j) Assistant county attorneys, or special investigators in the employ of the county attorney.

The classified service shall include all other offices or employments now existing or hereafter created in said counties and county agencies, and all officers and employees not expressly placed in the unclassified service by the terms of this act, notwithstanding any other provisions in any existing law to the contrary. It shall include officers and employees of such county agencies, if the funds for such agencies are provided in whole or in part by such county. For the purpose of clarity it shall include officers, except as excluded in subdivision (c) of Section 6 above, and employees of joint city hall and court house commissions and all other agencies supported and controlled in whole or in part by the said counties, or jointly by said counties and any city of the first class located therein; provided, however, that nothing herein shall apply to the officers and employees of board of county welfare.

CHAPTER 526—S. F. No. 1296 [Not Coded]

An act authorizing the Commissioner of Administration to sell certain property in the city of St. Peter, Minnesota, and authorizing the Governor and Secretary of State to execute the necessary instruments of conveyance.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Commissioner of Administration authorized to sell certain property in St. Peter, Minnesota. The Commissioner of Administration is hereby authorized to sell the following described property situated in the city of St. Peter, Nicollet County, Minnesota, to-wit:

Beginning at the intersection of a westerly extension of the center line of Jefferson Avenue and a southerly extension of the west line of Seventh Street (formerly Sixth Street), in the town, now city, of St. Peter, according to the amended plat thereof on file in the office of the Register of Deeds of Nicollet County, Minnesota; thence southerly along a southerly extension of the west line of said Seventh Street 420 feet; running thence easterly and parallel to the center line of said Jefferson Avenue 3062/3 feet, the point of commencement; thence southerly and at right angles 101 feet; thence southeasterly at an angle of 105 degrees and 15 minutes 529 feet to the right of way of the Chicago and Northwestern Railway Company; thence northerly along said right of way to a point 80 feet southerly of an easterly extension of the southerly line of Block 105, in the town of St. Peter, according to the original plat on file in the office of the Register of Deeds in and for said county; thence westerly and parallel with said line 4701/3 feet, more or less, to the point of commencement, and containing 1.86 acres, more or less; together with the vacated portion of the westerly extension of Wabasha Street adjoining the northerly side of said tract, for a sum not less than \$100, and the following described property, to-wit:

Beginning at the intersection of a westerly extension of the center line of Jefferson Avenue and a southerly extension of the west line of Seventh Street (formerly Sixth Street), in the town, now city, of St. Peter, according to the amended plat thereof on file in the office of the Register of Deeds of Nicollet County, Minnesota, and running thence southerly along a southerly extension of said west line of Seventh Street 420 feet to the point of commencement; thence easterly and parallel to the center line of Jefferson Avenue 306\%3 feet; thence southerly at right angles 101 feet to a point; thence northwesterly at an angle of 84 degrees and 45 minutes to the place of commencement, and containing 26/100 acre, more or less; together with the vacated portion of a westerly extension of Wabasha Street in said city adjoining the northerly line of said tract, for a sum not less than \$25.00.

Sec. 2. Execution of conveyance. The governor and secretary of state are hereby authorized to execute in behalf

of the state of Minnesota the necessary instruments so as to transfer the above described properties to the purchasers.

CHAPTER 527—S. F. No. 361 [Coded as Sections 540.151 to 540.154]

An act relating to judicial procedure, parties to actions, and service of judicial process and certain other notices.

Be it enacted by the Legislature of the State of Minnesota:

[540.151] Suability of certain persons and associations; labor organizations; employer organizations. Section 1. When two or more persons associate and act, whether for profit or not, under a common name, including associating and acting as a labor organization or employer organization, whether such common name comprises the names of such persons or not, they may sue in or be sued by such common name, and the summons may be served on one or more of them. The judgment in such cases shall accrue to the joint or common benefit of and bind the joint or common property of the associates, the same as though all had been named as parties to the action.

[540.152] Certain transactions or activities suable; service; notice; jurisdiction. Sec. 2. The transaction of any acts, business or activities within the State of Minnesota by any officer, agent, representative, employee or member of any Union or other groups or associations having officers, agents, members or property without the State on behalf of such Union or other groups or associations or any of its members or affiliated local unions shall be deemed an appointment by such Union or other groups or associations of the Secretary of State of the State of Minnesota to be the true and lawful attorney of such Union or other groups or associations, upon whom may be served all legal processes or notices in any action or proceeding against or involving said Union or other groups or associations growing out of such acts, business or activities within the State of Minnesota resulting in damage or loss to person or property or giving rise to any cause of action under the laws of the State of Minnesota or to any matters or proceedings arising under the Minnesota Labor Relations Act, and such acts, business or activities shall be
