

record with the register of deeds or registrar of titles, all within 30 days after the mailing of the notice of reversion. The appeal shall be tried by the court in like manner as a civil action. If no appeal is taken as herein provided, the declaration of reversion shall be final. The commissioner of taxation shall file for record with the register of deeds or registrar of titles, of the county within which the land lies, a certified copy of the declaration of reversion and proof of service.

CHAPTER 360—S. F. No. 706

An act relating to narcotic drugs; amending Minnesota Statutes 1945, Section 618.01, Subdivision 14; and Section 618.01, by adding subdivisions.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1945, Section 618.01, Subdivision 14, is amended to read:

Subd. 14. "Narcotic drugs" means coca leaves, opium, isonipicaine, *amidone*, *isoamidone*, *ketobemidone*, and every substance neither chemically nor physically distinguishable from them.

Sec. 2. Minnesota Statutes 1945, Section 618.01, is amended by the addition of three new subdivisions to read:

"Amidone" shall mean any substance identified chemically as (4, 4-Diphenyl-6-Dimethylamino-Heptanone-3), or any salt thereof, by whatever trade name or number identified.

"Isoamidone" shall mean any substance identified chemically as (4, 4-Diphenyl-5-Methyl-6-Dimethylaminohexanone-3), or any salt thereof, by whatever trade name or other name or number identified.

"Keto-bemidone" shall mean any substance identified chemically as [4-(3-Hydroxyphenyl)-1-Methyl-4-piperidyl ethyl ke-

tone hydrochloride] or any salt thereof, by whatever trade name or other name or number identified.

CHAPTER 361—S. F. No. 768

An act authorizing certain counties to issue bonds for improvement of poor farm buildings.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. St. Louis County Poor Farm authorized to improve. Any county having an area of not less than 90 or more than 101 full and fractional congressional townships and a taxable valuation of less than \$5,000,000, and which owns a county poor farm with buildings thereon, and operates under the county poor system, is authorized to issue bonds for the reconstruction, alteration, repair, and improvement of necessary buildings on such poor farm, in the sum of not exceeding \$50,000, to be payable within a period of not to exceed five years from the date of issuance.
