accordance with the rules of the board governing promotion, transfer, and demotion. In any case in which the incumbent is ineligible to continue in the position and he is not transferred, promoted or demoted, the layoff provisions of this chapter and the rules of the board shall apply. Personnel changes required by the reallocation of positions shall be completed within a period of sixty days following the date of reallocation notice to an appointing authority. Any employee with permanent or probationary status whose position is reallocated shall be considered eligible to compete in any promotional examination held to fill the reallocated position, as provided in the rules of the board.

- (6) A review by the board as provided for in this subdivision may be had when the employee or appointing authority affected files an application for review in writing on the ground:
- (1) That the action of the director was not in accordance with the civil service act;
- (2) That the action of the director was unwarranted by the evidence before him, or was procured by fraud, coercion or other improper conduct of any party in interest.

The board after receiving any application for review shall order the director to submit to it the record upon which he acted and thereafter, upon that record, may sustain, reverse or modify the action of the director or, in its discretion, may order that further evidence be taken by him to be submitted to the board and considered by it upon its review.

## CHAPTER 162-H. F. No. 777

An act relating to elections in certain cities of the fourth class; repealing Minnesota Statutes 1949, Sections 212.51 to 212.64.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Sections 212.51 to 212.64, are hereby repealed.
