## CHAPTER 176-H. F. No. 124

## [Coded as Section 471.84]

An act authorizing public corporations to transfer personal property for a nominal consideration or without consideration for use of the public.

Be it enacted by the Legislature of the State of Minnesota:

[471.84] Section 1. Transfer of property, one public corporation to another. Any county, city, village, borough, town, or school district may transfer its personal property for a nominal or without consideration to another public corporation for public use when duly authorized by its governing body.

## CHAPTER 177-H. F. No. 166

An act relating to the suspension of fiduciary powers during war service, and defining "war service"; amending Minnesota Statutes 1949, Section 501.45, Subdivision 1.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Minnesota Statutes 1949, Section 501.45, Subdivision 1, is amended to read:
- 501.45 Fiduciary powers, suspended during war service. Subdivision 1. Definitions. When used in this section unless the context otherwise requires:
- (a) "War service" includes, the following, during the period the United States is engaged in war or other major military engagement with any foreign nation:
- (1) Active membership in the military, naval, or air forces of the United States or any of its allies;
  - (2) Acceptance for membership in the military, naval,

or air forces of the United States or any of its allies and awaiting: induction into that service;

- (3) Participation in any work abroad in connection with a governmental agency of the United States or any of its allies, with the Red Cross, or with any other similar service;
- (4) Internment by an enemy or absence from the United States and inability to return;
- (5) Any service arising out of or in connection with the war or other major military engagement, which in the opinion of the court prevents the fiduciary from giving the proper attention to his duties.
- (b) "Fiduciary" refers to a trustee of a testamentary trust or of an express trust, a guardian of the person or estate of any person, an executor of a will, an administrator of the estate of the decedent, or an advisor or consultant in a testamentary or express trust.

## CHAPTER 178—H. F. No. 203 [Coded as Section 100.303]

An act relating to wild animals and providing for the transportation, sale, and disposal of the pelts of fur bearing animals and the skins or hides of other protected wild animals taken on certain Indian reservations.

Be it enacted by the Legislature of the State of Minnesota:

[100.303] Section 1. Pelts, skins, or hides taken on certain Indian reservations. The pelts of fur bearing animals and the skins or hides of other protected wild animals taken on any Indian reservation in this state except the Fond du Lac reservation of the Chippewa Indian tribe may be transported, sold, or otherwise disposed of under such rules, regulations, and conditions as the commissioner of conservation may prescribe.
