agency subject to rules and regulations made by the state agency;

(2) If the net value of his property or the net value of the combined property of husband and wife exceeds \$7,500; or if the net value of his assets convertible into cash exceeds \$300 or the combined convertible assets of husband and wife exceed \$450. The county agency in its discretion may permit eligibility of an applicant having liquid assets in excess of this amount when the liquidation of the assets would cause undue loss; provided, that household goods and furniture in use in the home, wearing apparel, and a lot in the burial ground may be owned in addition to the property limitation provided in this clause;

(3) Who has, after the passage of sections 256.11 to 256.43, or within two years prior thereto deprived himself directly or indirectly of any property for the purpose of qualifying for old age assistance;

(4) Whose spouse, living with the person, has made an assignment or transfer directly or indirectly of any property for the purpose of qualifying either person for old age assistance under sections 256.11 to 256.43.

Sec. 2. This act shall take effect and be in force from and after July 1, 1951.

## CHAPTER 226-S. F. No. 682

An act relating to salaries of county officials in certain counties and providing for clerk hire in said counties; amending Laws 1943, Chapter 411, Sections 4 and 6.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1943, Chapter 411, Section 4, is amended to read:

Sec. 4. County superintendent of schools, salary. The salary of the county superintendent of schools in any such county shall be fixed by the board of county commissioners and shall not be less than \$2,600 nor more than \$3,300 per annum. The superintendent of schools in any such county shall be allowed for clerk hire such sum as shall be fixed by the board of county commissioners.

Sec. 2. Laws 1943, Chapter 411, Section 6, is amended to read:

Sec. 6. Clerk hire. The amount paid for clerk hire in the office of the register of deeds and for deputy register of deeds in such county shall be fixed by the board of county commissioners.

## CHAPTER 227-S. F. No. 821

An act to designate as the Joseph R. Brown Memorial Drive a certain route along the Minnesota River.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Joseph R. Brown Memorial Drive. The following route along the Minnesota River is named and designated the "Joseph R. Brown Memorial Drive":

Beginning at a point on Statutory Route No. 122 at or near Mankato; thence extending in a westerly direction to the junction of County Aid Road No. 24; thence continuing westerly to the junction of County Aid Road No. 14; thence continuing westerly to County Aid Road No. 13 to a point where County Aid Road No. 13 travels in a northerly direction, at which point the parkway is to extend in a westerly direction along the Minnesota River to its intersection with County Aid Road No. 25; thence extending westerly on County Aid Road No. 25 to the junction of Constitutional Route No. 7; thence extending westerly on Constitutional Route No. 7 at its intersec-
