court bailiffs, one chief patrol deputy and *fourteen* assistants, one female deputy, four process servers, one chief jailer and nine assistants, one matron and *four* assistants, one bookkeeper-cashier, one principal clerk, two clerk-stenographers and one senior clerk-typist. Said chief patrol deputy shall be allowed \$75.00 per month for the operation of his automobile. The titles herein mentioned shall not be controlling but shall be subject to change by the county board or other lawful authority.

Sec. 2. This act shall be effective January 1, 1952.

CHAPTER 593—H. F. No. 1633

An act relating to hairdressing and beauty culture; stating the compensation of board members; amending Minnesota Statutes 1949, Sections 155.06 and 155.08.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Section 155.08, is amended to read:

155.08 Board members; compensation, expenses. Each member of the board except the secretary-treasurer shall receive the sum of \$15 for each day employed in the actual discharge of his official duties and any necessary expenses incurred incidental thereto. Compensation and expenses of and for the board shall be paid out of the funds of the board deposited in the state treasury and not otherwise.

Sec. 2. Minnesota Statutes 1949, Section 155.06, is amended to read:

155.06 Board; organization, rule, records, inspection. Subdivision 1. The board shall on the second Tuesday of each year assemble at the state capitol or at such other place as such board has established offices pursuant to the provisions of this chapter and then and there organize by electing from

among it members a president, a vice-president, and a secretary-treasurer to serve until their successors are elected and have qualified. The board shall appoint such assistants, inspectors, and clerical help as it may deem necessary to perform the work of the board. The appointments shall be made in accordance with the rules and regulations to be adopted by the board and chosen upon the basis of experience, training, and general qualifications for the work. Necessary expenses incurred in the transaction of the business of the board and the salaries and necessary expenses of assistants, inspectors, and clerical help shall be fixed by the board. The total sum of money to be expended for the salaries of the assistants, inspectors, and clerical help and other necessary expenses connected with the work shall not exceed the sum of \$30,000 per annum. The board shall maintain an office for the conduct of its business. The secretary-treasurer and such other persons as are charged with and actually handle the funds of the board shall provide to the State of Minnesota a corporate surety bond in the amount of \$10,000. The secretary-treasurer of the board shall maintain its office and devote his entire time to the duties thereof and receive an annual salary of \$3,600, payable in semimonthly installments, and any necessary expenses incurred in the performance of his official duties.
