Notwithstanding the provisions of Minnesota Statutes, Section 490.03, any judge of the district court who has heretofore retired whose retirement compensation is less than \$354.16 per month shall receive as retirement compensation for the time provided in the statutes in force at the time such judge retired but commencing as of January 1, 1951, the sum of \$354.16 per month during such time.

CHAPTER 622—S. F. No. 1425

[Not Coded]

*An act authorizing and directing the governor and the state auditor to execute a deed to certain lands for the purpose of correcting an erroneous description of lands described as parcel 2 in the deed of the state of Minnesota dated September 30, 1947, executed pursuant to authority of Laws 1947, Chapter 139.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. Conveyance of land to Shattuck School.** The governor and the state auditor are hereby authorized and directed to execute and deliver in the name of the State of Minnesota, as grantor, to Shattuck School, a corporation, of Faribault, Minnesota, a deed conveying all the interest and estate of the State of Minnesota in the following described land, lying and being in the County of Rice and State of Minnesota:

Beginning at the southeast corner of the West Half of the Northeast Quarter of the Southwest Quarter of Section Twenty-nine, Township One Hundred Ten, Range Twenty West; thence west along the south line of the Northeast Quarter of the Southwest Quarter of said section a distance of 331.84 feet more or less to the northeast corner of the Northwest Quarter of the Northwest Quarter of the Southeast Quarter of the Southwest Quarter of said section; thence south along the east line of the Northwest Quarter of the

Northwest Quarter of the Southeast Quarter of the Southwest Quarter a distance of 200 feet; thence east parallel with the north line of the Southeast Quarter of the Southwest Quarter of said section to the north and south quarter line of said section; thence north along the north and south quarter line of said section to the northeast corner of the Southeast Quarter of the Southwest Quarter of said section; thence west along the north line of the Southeast Quarter of the Southwest Quarter of said section to the point of beginning.

CHAPTER 623—S. F. No. 1331

[Coded as Section 117.133]

*An act relating to eminent domain proceedings and providing for a jury trial on appeals to the district court.*

Be it enacted by the Legislature of the State of Minnesota:

[117.133] Section 1. **Jury trial.** In all eminent domain proceedings wherein an appeal is taken to the District Court from the award of the Commissioners or from the award of the governing body of any city, county or political subdivision making the award, the property owner or the condemnor shall be entitled to a jury trial in the District Court as a matter of right notwithstanding the provisions of any charter or ordinance denying such right.

CHAPTER 624—S. F. No. 1336

*An act relating to fees of register of deeds in counties of this state having a population of more than 450,000; amending Minnesota Statutes 1949, Section 357.19.*

Be it enacted by the Legislature of the State of Minnesota:
