- Section 1. Wright County, salary of probate judge. In all counties of this state now or hereafter having not less than 27,000 nor more than 28,000 inhabitants according to the last federal census, and having a taxable valuation exclusive of money and credits of not less than \$11,000,000, the annual salary of the judge of probate court shall be \$4,000.

CHAPTER 652-H. F. No. 863

[Not Coded]

An act relating to any game preserve, area, or project established pursuant to Minnesota Statutes 1949, Sections 84A.01, 84A.20, or 84A.31, appropriating money out of the consolidated conservation areas fund.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Appropriation, forest fire prevention. There is appropriated out of the moneys in the Consolidated Conservation Areas Fund in the state treasury, not otherwise appropriated, to the commissioner of conservation to be expended under the authority conferred upon him by Minnesota Statutes 1949, Section 84A.55, Subdivision 2, and for the purposes thereof, the sum of \$150,000.
- Sec. 2. Appropriation, wild life protection. There is appropriated out of the moneys of the Consolidated Conservation Areas Fund in the state treasury, not otherwise appropriated, to the commissioner of conservation to be expended under the authority conferred upon him by Minnesota Statutes 1949, Section 84A.55, Subdivision 5, and for the purposes thereof, the sum of \$25,000.
- Sec. 3. Appropriation, repair of ditches. There is appropriated out of the moneys in the Consolidated Conservation Areas Fund in the state treasury, not otherwise appro-

priated, to the commissioner of conservation to be expended under the authority conferred upon him by Minnesota Statutes 1949, Section 84A.55, Subdivision 9, and for the purposes thereof, the sum of \$100,000.

Sec. 4. Reappropriation. Any unexpended funds after the first year of the biennium are hereby reappropriated for use in the second year of the biennium.

CHAPTER 653—H. F. No. 965 [Not Coded]

An act providing for the appointment of a clerk by and for the juvenile court in counties having more than 300,000 and less than 450,000 inhabitants, and for his salary.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Ramsey County, clerk of juvenile court. The judge of the district court presiding over the juvenile court in districts having therein a county having more than 300,000 and less than 450,000 inhabitants shall appoint a clerk of the juvenile court for such county who thereafter shall serve as such clerk of juvenile court unless removed for cause by the judge then presiding over such juvenile court, who shall not be under civil service, and whose salary shall be fixed by the board of county commissioners, and shall not exceed the sum of \$4,500.

CHAPTER 654—H. F. No. 1080

An act relating to the improvement of public waters in counties now or hereafter having a population of 500,000 inhabitants or more, and providing for an election to be held on the question thereon; amending Minnesota Statutes 1949, Section 110.127, Subdivision 2.
