nesting conditions and experience similar over-lapping flights of wild fowl in season; and

WHEREAS, Minnesota has co-operated with the fish and wild life service and federal authorities at all times, notably setting aside refuges for water fowl of far more acreage than any other state.

Now Therefore, Be It Resolved by the Legislature of the State of Minnesota:

- (1) That the federal fish and wild life service of the Department of the Interior, Washington, D. C. be requested to reclassify Minnesota in respect to its determination of flyways so that the States of North Dakota and Minnesota enjoy equal privileges under such re-classification of fly-ways and the states allotted thereto;
- (2) That copies of this Resolution be sent to Albert M. Day, Director of Fish and Wild Life Service, Washington, D. C., to the Secretary of the Interior at Washington, D. C. and to each member of the Congress from the State of Minnesota.

RESOLUTION No. 10-H. F. No. 1091

A joint resolution authorizing a statue to be erected upon the grounds of the State Capitol as a memorial to the late Governor Floyd B. Olson; providing for a commission to be appointed to receive public subscriptions and donations to pay for the cost thereof and its expenses.

WHEREAS, Floyd B. Olson served the state of Minnesota for two terms and part of another term as governor, during which service the people of our state came to revere him for his rugged, sterling character, his statesmanship, his courage and his devotion to the principles which he believed to be right, and

WHEREAS, his leadership of the government of our state took place during a period of economic chaos which confronted our state and nation with unparalled problems of reconstruction and recovery and his distinguished service as governor and as the champion of liberal causes in our state did much to alleviate the distress and hardship experienced by the vast majority of our people in these distressing times, and

WHEREAS, it is believed the memory of the great leader of our democracy may be further honored and perpetuated among all our people with the erection of a suitable monument upon the grounds and near the approach to our state capitol building,

Now, Therefore, Be It Resolved by the Legislature of the State of Minnesota, as follows:

- 1. That a suitable statue sculptured in the image and likeness of the late Floyd B. Olson, Governor of Minnesota from January 6th, 1931 until August 23rd, 1936, is hereby authorized to be constructed of stone or other durable material and to be erected upon the grounds of the state capitol at a suitable place near the approach of the state capitol building;
- 2. The commissioner of administration is hereby authorized and directed to carry out the provisions of this resolution, and to cause the custodian of the state capitol building to designate the location of the statue as soon as sufficient funds furnished to him for such purpose, as hereinafter profunds have been furnished to him for such purpose, as hereinafter provided.
- 3. A commission of five members, consisting of two members of the Senate, to be appointed by the Committee on Rules and Legislative Expense, and two members of the House of Representatives, to be appointed by the Speaker, and one member at large, to be appointed by the Governor, is hereby created and authorized to receive sufficient funds for the purpose of carrying out the provisions of this resolution through voluntary public subscriptions and donations. Such commission shall serve without compensation, but may defray their expenses from such contributions in an amount not exceeding ten per cent of the funds subscribed or donated.

RESOLUTION No. 11-H. F. No. 655

A joint resolution memorializing the President, the Secretary of the Treasury and the Congress of the United States to oppose measures altering the tax status of cooperatives.
