BE IT FURTHER RESOLVED that copies of this Resolution be forwarded to the Secretary of Defense, to the Secretary of the Army, to the Chief of the National Guard Bureau, and to each Senator and Representative in Congress from the State of Minnesota.

RESOLUTION No. 8—H. F. No. 394

*A joint resolution memorializing the Congress of the United States to continue furnishing food, feed, and fiber to countries of Europe and Asia in an effort to resist Communist aggression.*

WHEREAS, hunger and want breed tyranny and facilitate the encroachment of Communism on the countries of Europe and Asia and cause the espousal of unsound forms of government; and

WHEREAS, food, feed and fiber, by alleviating conditions of hunger and want, will assist in the maintenance of independent and democratic peoples; and

WHEREAS, the furnishing of food, feed and fiber by this country will strengthen and encourage the development of democracy in Europe and Asia and tend to create amity between this country and the recipients of such food, feed and fiber; and

WHEREAS, the furnishing of food, feed and fiber to friendly countries in Europe and Asia will assist them in resisting Communist aggression and also tend to minimize the potential military effort of the United States in Europe and Asia; and

WHEREAS, the food, feed and fiber will strengthen the forces of those countries espousing democratic principles and

will be to the mutual advantage of countries resisting communistic aggression;

NOW, THEREFORE, BE IT RESOLVED by the Legislature of the State of Minnesota, that the Congress of the United States be memorialized to continue and increase the supply of food, feed and fiber sent to friendly peoples in Europe and Asia, and that such food, feed and fiber be furnished out of surplus stockpiles on hand, and that supervision and distribution be made directly to the countries friendly to the United States, and that such products be so identified as to the source of materials involved.

BE IT FURTHER RESOLVED, that the Secretary of State transmit a copy of this resolution to the Secretary of the Senate and Chief Clerk of the House of Representatives of the United States and each of the nine congressmen from the State of Minnesota, and both of the United States Senators.

RESOLUTION No. 9—H. F. No. 1265

*A joint resolution memorializing the federal fish and wild life service of the United States Department of Interior and the Congress of the United States to take necessary action to assure equal treatment for Minnesota as compared with North Dakota and other states in respect to seasons and bag limits under presently defined fly-ways.*

WHEREAS, the federal fish and wild life service of the Department of the Interior at Washington, D. C. determined in 1950, the existence of four separate fly-ways, namely, the Atlantic, Mississippi, Central and Pacific fly-ways, and allotted to the Mississippi fly-way including the State of Minnesota a 35-day season on wild fowl and a daily bag limit on ducks of four and eight in possession, with a similar season for geese; and allotted to the Central fly-way, including the state of North Dakota, a 45-day season with a daily bag limit on ducks of five and ten in possession with a similar season on geese; and

WHEREAS, the division of the Mississippi and the Central fly-ways having in common the border between North Dakota and Minnesota effects an unwarranted discrimination against the people of Minnesota as these two states have similar local
