

or orders of said judge, so given or rendered in open court or dictated at chambers to said reporter. Each of said reporters shall, when requested by the judge so appointing him, without charge therefor, transcribe said notes, or any part thereof, for the use of said judge, or for such other purposes in furtherance of justice as said judge may order; and each of said reporters shall furnish a typewritten copy of said notes, or any part thereof, at the request of any party to an action in said court, for which copy he shall be entitled to charge at the rate of *twenty (20) cents per folio*. The amount paid by any party for such copy to be used upon a motion or an appeal may be taxed and allowed as other disbursements are taxed and allowed in an action.

CHAPTER 197—S. F. No. 1016

*An act authorizing the commissioner of agriculture, dairy, and food to adopt standards, definitions and grades for milk and cream purchased for manufacturing purposes, and amending Laws 1947, Chapter 396, Section 2, as amended.*

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Laws 1947, Chapter 396, Section 2, as amended by Laws 1949, Chapter 196, Section 2, is amended to read :

Sec. 2. [32.491 Subd. 2.] **Purchases based on grades; statement, contents.** All milk or cream purchased for manufacturing purposes shall be purchased on the basis of the standards and grades so adopted. *Every purchaser of milk or cream for manufacturing purposes shall, at time of payment for same, furnish the person from whom the same was purchased a statement showing the date of grading of the milk or cream, the grade of the milk or cream, and the price paid therefor. Such statement may be included on the check delivered by the purchaser to the seller in payment of such milk or cream.*

*An act relating to salaries of county officers in certain*

*counties; amending Laws 1947, Chapter 476, Sections 1 and 5, as amended.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1947, Chapter 476, Section 1, as amended Laws 1949, Chapter 370, Section 1, and Laws 1951, Chapter 665, Section 1, is amended to read:

Section 1. **Otter Tail county, officers' salaries.** In all counties of this state with a population of 50,000 but less than 60,000 inhabitants, based on the population according to the then last preceding state or federal census, the respective county officers shall receive as compensation for services rendered by them for their respective counties, annual salaries as follows:

(1) County Auditor .....	\$4800.00
(2) County Treasurer .....	\$4800.00
(3) Judge of Probate Court .....	\$4800.00
(4) Register of Deeds .....	\$4800.00
(5) County Superintendent of Schools .....	\$4500.00
(6) Sheriff .....	\$4800.00
(7) Clerk of District Court .....	\$4800.00
(8) County Attorney .....	\$4000.00
(9) County Commissioners .....	\$1200.00

#### CHAPTER 199—S. F. No. 1137

*An act relating to compensation for election services; Amending Minnesota Statutes 1949, Section 200.35, as amended by Laws 1951, Chapter 367.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Section 200.35, as amended by Laws 1951, Chapter 367, is amended to read:

200.35 **Election services, compensation.** The compensation for services performed under chapters 200 to 212 shall be as follows:

(1) To presidential electors, \$10 for each day's attendance at the capitol, and *seven* cents for each mile necessarily
