484.15 Seventh judicial district. General terms of district court in the counties constituting the seventh judicial district shall be held each year at the times herein specified:

Becker County: On the first Monday in March and the first Monday in October.

Benton County: On the second Monday in February and the second Monday in September.

Clay County: On the second Monday in April and the second Monday in November.

Douglas County: On the first Monday in March and the first Monday in October.

Mille Lacs County: On the third Monday in March and the first Monday in October.

Morrison County: On the second Monday in April and the second Monday in November.

Otter Tail County: On the second Monday in April and the second Monday in November.

Stearns County: On the second Monday in April and the second Monday in November.

Todd County: On the first Monday in March and the first Monday in October.

Wadena County: On the second Monday in February and the second Monday in September.

CHAPTER 273—S. F. No. 1242

An act relating to primary elections in certain villages; amending Minnesota Statutes 1949, Section 212.381, Subdivision 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Section 212.381, Subdivision 2, is amended to read:

The primary election shall be held not Subd. 2. Date. less than ten days nor more than 14 days preceding the village election to be determined by the governing body, provided that in a village having voting machines the primary election may be held on the first Tuesday after the first Monday in November. The clerk or recorder of such village shall give at least ten days posted notice or notice published in the official newspaper of the time and place of holding the same, of the hours during which the polls will be open, and of the offices for which candidates are to be nominated. All voting at the primary election shall be by ballot. The clerk or recorder of the village shall, at least one week before the primary election, cause to be published a sample of the village primary ballot in the official newspaper of such village, or if there is no newspaper therein in the official newspaper of the county in which said village is situated, and shall also post a sample printed copy in his office for public inspection. The judges and clerks of election shall certify the results of said primary election to the governing body of the municipality, which shall forthwith canvass the vote and shall issue certificates of nomination to the two candidates for each office receiving the highest number of votes. Thereafter, the names of the two candidates receiving the highest number of votes shall be placed upon the ballot for the general election.

CHAPTER 274—H. F. No. 12

An act relating to scholarships for students in accredited schools of nursing and making appropriation therefor.

Be it enacted by the Legislature of the State of Minnesota:

Scholarships, student nurses. Section 1. [148.295] [Subdivision 1.] Entitlement, use, amount. board of education may award scholarships to students attending a school of nursing in this state accredited in accordance with the laws pertaining to registered nurses and licensed practical nurses. Such scholarships shall be awarded to those students who are residents of this state and who are in need of economic assistance in securing such nursing education, and shall be awarded on the basis of need and ability. These scholarships shall be used solely to defray tuition and other fees and expenses incidental to such nursing education, and shall be awarded only to students enrolled in a school of nursing which provides students an educational experience in a rural or a state
