 - (2) For a seine in excess of 500 feet, but not over 1,000 feet, \$30.00;
 - (3) For each 100 feet of seine in excess of 1,000 feet, \$2.00;
 - (4) For helper's license, \$5.00.

CHAPTER 298—S. F. No. 944

An act relating to the licensing of electricians and creating master electricians classification; amending laws 1947, Chapter 253, Section 5, Subdivision 1, Section 6, Subdivision 1 and Section 7, as amended.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1947, Chapter 253, Section 5, Subdivision 1, as amended by Laws 1949, Chapter 550, Section 1, and Laws 1951, Chapter 571, Section 1, is amended to read:

Sec. 5. **Master electrician, class B.** Subdivision 1. **Temporary classification.** There is hereby created a temporary Class B master electrician's classification. The holder of a license heretofore granted under this provision may continue as such temporary Class B master electrician until he qualifies as a master electrician as prescribed by law, but in no event shall such classification as herein provided for extend beyond December 31, 1955.

Sec. 2. Laws 1947, Chapter 253, Section 6, Subdivision 1, as amended by Laws 1949, Chapter 550, Section 2, and Laws 1951, Chapter 571, Section 2, is amended to read:

Sec. 6. **Journeyman electrician, class B.** Subdivision 1. **Temporary classification.** There is hereby created a temporary Class B journeyman electrician's classification. The holder of a license heretofore granted under this provision may continue as such temporary journeyman Class B electrician until he qualifies as a journeyman electrician as prescribed by law, but in no event shall such classification as herein provided for extend beyond December 31, 1955.

Sec. 3. Laws 1947, Chapter 253, Section 7, as amended by Laws 1949, Chapter 550, Section 3, and Laws 1951, Chapter 571, Section 3, is amended to read:

Sec. 7. Application, other laws. As far as possible, all provisions of sections 326.24 to 326.32 shall apply to temporary Class B license classifications. No such license shall remain in effect beyond December 31, 1955.

CHAPTER 299—S. F. No. 1021

An act relating to charges made by sheriffs and counties for boarding, maintaining and providing jail facilities for other than county prisoners; amending Minnesota Statutes 1949, Section 641.13, as amended.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1949, Section 641.13, as amended by Laws 1951, Chapter 319, Section 1, is amended to read:

641.13 Charges, prisoners from other counties. When any prisoner is ordered confined in any county other than that in which his offense was committed, the sheriff of such other county shall keep him at the expense of the county sending him, and the sheriff of such other county shall collect from the county sending him, for his board \$2 for each day, or fractional day, and, in addition thereto, the county board of such other county shall collect from the county sending such prisoners, such sums as shall have been necessarily expended for clothing, bedding, and medical aid for such prisoners. In addition thereto the county board of such other county may collect from the county sending such prisoners such sum as the county board may determine but not to exceed \$1 per day for other expenses incurred by such other county in providing jail facilities for such prisoners. The county board of the county from which such prisoners are sent, at its first session after their commitment, shall authorize the county auditor to issue to the sheriff of the county where they are committed orders upon the county treasurer for the maintenance of such prisoners while they remain in such jail.

Sec. 2. Any charges heretofore made pursuant to the provisions of section 641.13 are hereby legalized and validated as against the objection that the charges so made exceeded the maximum charges permitted therein.
