

CHAPTER 101—S. F. No. 80

An act relating to grand larceny, second degree; amending Minnesota Statutes 1953, Section 622.06.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1953, Section 622.06, is amended to read:

622.06 Grand larceny, second degree, punishment. Every person who, under circumstances not amounting to grand larceny in the first degree, in any manner specified in this chapter, *steals* or unlawfully *obtains* or *appropriates*:

(1) Property of the value of more than \$100 but not exceeding \$500 in any manner;

(2) Property of any value by taking *it* from the person of another;

(3) Property of any value by taking *it* in the daytime from any dwelling house, office, bank, shop, warehouse, vessel, motor vehicle, railway car, or building;

(4) Property of less value than \$25 by taking *it* in the nighttime from any dwelling house, office, bank, shop, warehouse, vessel, motor vehicle, railway car, or building; or

(5) A record of a court or officer or a writing, instrument, or record kept, filed, or deposited according to law with or in keeping of any public officer

Is guilty of grand larceny in the second degree and may be punished by imprisonment in the state prison for not more than five years, by imprisonment in the county jail for not more than one year, or by a fine of not more than \$500.

CHAPTER 102—S. F. No. 198

An act relating to the Sandstone State Hospital; amending Minnesota Statutes 1953, Section 253.014.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1953, Section 253.014, is amended to read:

253.014 Sandstone State Hospital. The institution at Standstone, formerly the federal correctional institution which

is now operated by the state, is hereby established, for such period of time as it may be operated by the state, as a hospital for the care and treatment of mentally ill or mentally deficient persons, and male alcoholic inebriates, committed either voluntarily or involuntarily as now provided by law, which shall be known and designated as the Sandstone State Hospital.

CHAPTER 103—S. F. No. 26

An act to provide for a special federal census under certain circumstances in towns located in a county in which is located a city of the first class and having a population of not less than 350,000 and not more than 450,000.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Towns, special census. Whenever a new village is incorporated in a county in which there is located a city of the first class and having a population of not less than 350,000 and not more than 450,000, the board of supervisors of the town as defined in Minnesota Statutes, Section 368.01, of which the village was formerly a part, may at any time after such new incorporation provide for a special census to be taken to determine the population of the remaining portion of the town. This census shall be taken by the United States Census Bureau pursuant to the federal laws, rules and regulations thereunto pertaining, and a report of federal census so taken shall be obtained by the governor from the director of the federal census and shall be filed with the secretary of state as provided in Minnesota Statutes, Section 600.18. The population of the town for all purposes shall thereafter, and until the next federal decennial census, be the number so reported.

Sec. 2. Agreement with federal director of the census. The board of supervisors of any town authorized by this act to obtain a special census is hereby authorized and empowered to enter into the necessary agreements with the federal director of census and to expend town funds for that purpose.
